





AI requires massive energy, yet the County repeatedly sites industrial-scale renewable and battery projects in Boulevard/Campo/Jacumba while the rest of the region benefits. We already host Tule Wind, Sunrise Powerlink, Boulevard Energy Storage (BESS), and now JVR Solar is underway near Jacumba. More is proposed: Starlight Solar and Desert Jewel BESS.
