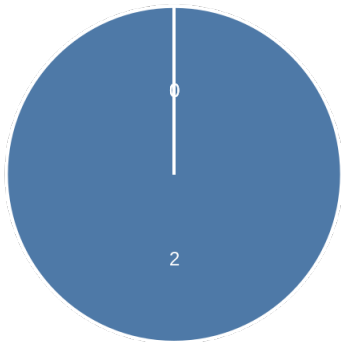

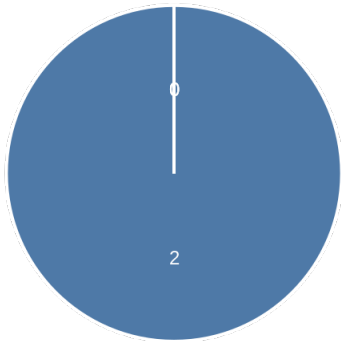

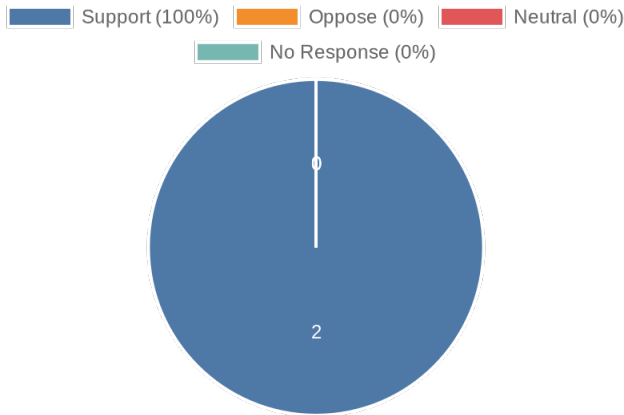

Mental health is a human right, and access to care should not depend on wealth, privilege, or luck. No one should have to wait until they are in crisis to receive help. This initiative is a necessity, not a luxury—especially as we face an escalating homelessness crisis and growing mental health concerns among younger generations. Right now, too many people—families, children, and individuals experiencing homelessness—are struggling to find the mental health care they need. One in three San Diegans relies on Medi-Cal, yet behavioral health resources remain fragmented and difficult to navigate. Without early intervention, small struggles turn into homelessness, unnecessary hospitalizations, or preventable interactions with law enforcement. This does not just harm individuals—it impacts families, workplaces, and entire communities.
