 AN ORDINANCE AMENDING ARTICLE XX OF THE SAN DIEGO COUNTY  
 ADMINISTRATIVE ORDINANCE CODE, RELATING TO  
 SAN DIEGO COUNTY FIRE, SAN DIEGO COUNTY EMERGENCY MEDICAL SERVICES, AND  
 COUNTY SERVICE AREA 17 CHARGES AND FEES

The Board of Supervisors of the County of San Diego ordains as follows:

**Section 1.** The Board of Supervisors finds and determines that San Diego County Fire must amend their charges and fees to recover actual expenses incurred by the Fire Code Official in the administration of various services and responsibilities. The amendments made by this ordinance are intended to allow the Fire Code Official to recover actual expenses for certain services provided by San Diego County Fire.

**Section 2.** Section 362.5, 366, 367, 368, 369, & 370 of the San Diego County Administrative Code are hereby amended to read as follows:

**SEC. 362.5. SAN DIEGO COUNTY FIRE AUTHORITY**

The following fees and charges shall be paid to San Diego County Fire Authority or the County collection agent for providing the following services:

(b) **OTHER FEES, DEPOSITS AND PROVISIONS.**

1. When a project is not specifically listed in the Permit fee table (subsection a) the fee shall be calculated using the standard hourly rates described in subsection (b)(3) of this section.

~~2. CHARGES FOR SPECIALIZED WORK. Information, maps, circulars and other specialized mapping or GIS based reports prepared by San Diego County Fire may be charged for using the standard hourly billing rates listed in subsection (b)(3) of this section.~~

~~4. INSPECTIONS OUTSIDE OF NORMAL BUSINESS HOURS. When the Fire Code Official approves requests for service outside of normal business hours, such as plan reviews and inspections, the fee shall be calculated using the rate of one and one half times the standard hourly rate described in subsection 362.4(b)(3).~~

3. PLAN REVIEW AND INSPECTION FEES FOR RESIDENTIAL TRACTS. When a plan is registered with the Building Official as a Master Plan, fees will be assessed for each unique floor plan for the building and automatic fire sprinkler plan reviews. Each dwelling unit in the phase will be assessed inspection fees. If there are no new unique floor plans in subsequent phases of the residential tract, fees will be assessed for only the inspection of each dwelling unit in the phase.

4. FEE WAIVER FOR STRUCTURES DAMAGED OR DESTROYED BY NATURAL DISASTER. The plan review fee and inspection fees may be waived for an applicant who is rebuilding legally built structures which have been damaged or destroyed by a wildfire or other natural disaster and which are located within the boundaries of a geographic area which has been declared by resolution of the Board of Supervisors to be eligible for this fee waiver. The fee waiver shall not apply to any portion of a new structure which exceeds the square footage of the structure which is being replaced.

5. HOMEOWNER AND BUSINESS OWNERS RELIEF - WAIVER OF PLAN REVIEW AND INSPECTION FEES. Notwithstanding the fees otherwise specified in subsections (a) and

(b) of this section, and San Diego County Code Section 91.1.109, the plan check review and inspection fees shall not be charged for improvements identified in subsections (10), (11) and (12) of Section 362.1(d) of the San Diego County Administrative Code, provided the improvement has not been previously identified as a violation by the County.

6. FEE WAIVER FOR DISABLED VETERANS. Notwithstanding the fees otherwise specified in subsections (a) and (b) of this section, the plan check and inspections fees shall be waived for accessibility modifications made to the homes of disabled veterans.

7. AUTHORITY TO WAIVE FEES. The Fire Code Official shall have the authority to waive fees for a project when the scope of work is minor in nature, the plans can be reviewed over the counter without additional research and will not necessitate an inspection for fire code related issues.

8. APPLICABILITY. This chapter shall be applicable in the unincorporated territory of the County of San Diego, where the County Fire Code Official provides the services, including within a fire protection district or municipal water district which provides fire protection service, if the district has entered into a Memorandum of Understanding or other agreement with the County to provide fire plan review and inspection.

~~A fee of \$900.00 and a mileage charge of \$20.00 per mile (minimum 1 mile) shall be charged to residents of County Service Area 69 who are transported from within County Service Area 69 territory for Basic or Advanced Life Support to a hospital by a County Service Area 69 provider. The Deputy Chief Administrative Officer or designee may waive said fee for those residents financially unable to pay the fee.~~

A fee of \$2,500.00 and a mileage charge of \$40.00 per mile (minimum 1 mile) shall be charged for transports originating from a territory outside of County Service Areas 17 and 69 to a hospital by a County Service Area 17 or 69 provider.

**SEC. 369. COUNTY SERVICE AREA 17 RESIDENT USER FEE AND SAN DIEGO COUNTY FIRE PROTECTION DISTRICT GROUND AMBULANCE SERVICE AREA AMBULANCE TRANSPORT FEES.**

A fee of \$400.00 and a mileage charge of \$20.00 per mile (minimum 1 mile) shall be charged to residents of County Service Area 17 who are transported from within County Service Area 17 territory for Basic or Advanced Life Support to a hospital by a County Service Area 17 provider. The Deputy Chief Administrative Officer or designee may waive said fee for those residents financially unable to pay the fee.

A fee of \$3,743 and a mileage charge of \$48.00 per mile shall be charged for each Emergency Medical Services (EMS) ambulance transport made to a medically approved destination, pursuant to County of San Diego EMS Policies when provided by the County Service Area 17 and the San Diego County Fire Protection District. Alternatively, an EMS ambulance transport may conclude at a rendezvous location, where the patient transport may transfer to another provider. A fee of \$460 shall be charged when EMS responders provide an assessment and treatment, but no patient transport. If more than one transport is provided to a patient (for example, due to a transfer at a rendezvous location), each transport provider may charge the patient the applicable fee and charges. If more than one patient is transported in the same vehicle, the transport provider may charge each patient the applicable fee and charges. There is a fee of \$235 per hour for requested special event and/or standby coverage for contracted services. The Fire Chief or designee may waive any applicable fee and charges for individuals financially unable to pay.

~~—(b)— A fee of \$3,395 and a mileage charge of \$44.00 per mile shall be charged for each Emergency Medical Services (EMS) ambulance transport made to a medically approved destination, pursuant to County of San Diego EMS Policies when provided by the San Diego County Fire Protection District. Alternatively, an EMS ambulance transport may conclude at a rendezvous location, where the patient transport may transfer to another provider. A fee of \$417 shall be charged when EMS responders provide an assessment and treatment, but no patient transport. If more than one transport is provided to a patient (for example, due to a transfer at a rendezvous location), each transport provider may charge the patient the applicable fee and charges. If more than one patient is transported in the same vehicle, the transport provider may charge each patient the applicable fee and charges. There is a fee of \$213 per hour for requested special event and/or standby coverage for contracted services. The fees in this section shall increase 5% on July 1, 2024, each new Fiscal Year through June 30, 2026. The Fire Chief or designee may waive any applicable fee and charges for individuals financially unable to pay.~~
