A-87, Competitive Procurement

BOARD POLICY STATEMENTS:

Board Policy A-87, Competitive Procurement - Authority to amend and extend the current contract with Sicuro Data Analytics, LLC for enhanced criminal justice data analysis.

Item and Service and Term Period: Services include the collection, identification, extraction, and analysis of criminal justice data granting the DAO complete, accurate, and timely analysis in accordance with current and forthcoming legislation. The proposed term is through August 31, 2026 with four option years, and an additional six months if needed.

Benefits to the County of San Diego: Access to accurate and timely data facilitates objective and fair justice proceedings. The proposed action will enhance local law enforcement operations, resulting in strategic and data-driven processes, and ultimately equitable outcomes throughout San Diego communities.

Justification: A-87(1)(D)(3): This procurement is for services from a provider with unique knowledge specific to San Diego County's criminal justice system, skills, and abilities not available from other sources. Continuing work with this provider will provide efficiencies unattainable from other providers and guarantee the DAO's compliance with state legislature.

Sicuro Data Analytics, LLC is well-positioned to use its prior extensive experience with the San Diego County District Attorney's Office and other California Counties, such as Riverside and San Bernardino, to streamline data and analytics for San Diego County. Sicuro meets all required security certifications to access criminal justice information, including the Federal Bureau of Investigation's Criminal Justice Information Services (CJIS) and California Law Enforcement Telecommunications Systems (CLETS) compliance and background.

Fair and Reasonable Price: All contracts are subject to negotiation and determination of a fair and reasonable price. Fair and reasonable pricing will be determined based on comparison to similar data services.
