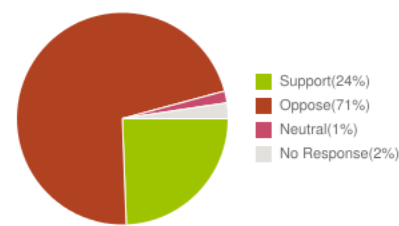

Overall Sentiment



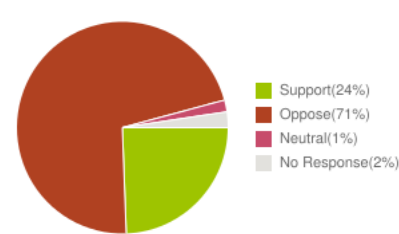

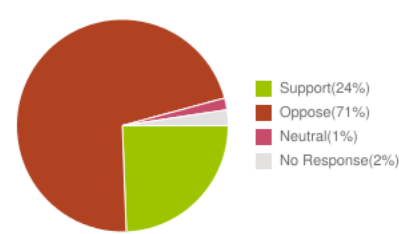
