

## **Overall Sentiment**







In designing the bike lanes for this project, ready access for utility, fire and law enforcement access from travel lanes to the curb line must be maintained. Utility agencies have appurtenances for water, wastewater, and communication services which must be accessed for routine and emergency service. Fire apparatus must be able to pull close enough to curb to engage fire hydrants located behind curbline. Finally, law enforcement needs to be able to pull over cars for traffic stops from the traffic lanes to the curbline. Without the ability to cross through a bike lane delineator, all of these entities would be forced to operate from the traffic lanes, impeding traffic flow and reducing public safety.

Clearly, any bike lane delineators installed with this project must be of a flexible design, allowing vehicle access from the traffic lane to the curbline for critical utility and public safety purposes.
