





The San Diego region has far too few withdrawal management (WM) and residential treatment beds for Medi-Cal clients with SUD. This problem will continue to deteriorate as jail diversion expands. In addition to expanding WM capacity, the County should expedite the implementation of SB1154, the Community Paramedicine or Triage to Alternate Destination Act, which permits trained paramedics to better match destination with the presenting needs of individuals with certain SUD and behavioral issues.

Voluntary SUD treatment is more robust than involuntary SUD treatment. In the SUD Provider Operations Handbook, if a patient lacks capacity, "treatment at another level of care or type of service is indicated." However, there is no option in SD for step-down involuntary SUD treatment equivalent to step-down involuntary MH treatment. Despite WIC 5350 including "chronic alcoholism" as reason for LPS conservatorship, no inpatient options exist due to CCR Title IX 1820.205 diagnoses exclude SUD.
