ORDINANCE NO. 10969 (NEW SERIES)

ORDINANCE ADDING SECTION 72.169.8.4., AMENDING SECTIONS 72.161.9., 72.169.54., AND 72.169.58., AND DELETING SECTIONS 72.161.9.1., AND 72.169.75. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.8.4. of the San Diego County Code is hereby added:

SEC. 72.169.8.4. FALLBROOK. The prima facie speed limit on Rainbow Heights Road from the east line of Rice Canyon Road easterly to the end of County maintenance (Sombrero, private road) is hereby decreased to and established at 30 miles per hour.

Section 72.161.9. of the San Diego County Code is hereby amended:

SEC. 72.161.9. RANCHO SANTA FE. The prima facie speed limit on Rambla de las Flores from the south line of La Granada southerly to the west line of Linea del Cielo is hereby decreased to and established at 35 miles per hour.

Section 72.169.54. of the San Diego County Code is hereby amended:

SEC. 72.169.54. FALLBROOK. The prima facie speed limit on Stage Coach Lane from the east line of Mission Road to the south line of Fallbrook Street is hereby decreased to and established at 40 miles per hour.

SEC. 72.169.75.


