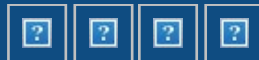

I hope this message finds you well. My name is Emma Magana, and I am a licensed dental professional residing in Vista, California. I am writing to express my concerns about recent legislative changes in several states that expand the scope of practice for dental assistants to include procedures such as dental scaling and the administration of local anesthesia.

- Oregon: Effective January 1, 2025, Expanded Function Dental Assistants (EFDAs) who obtain a Local Anesthesia Functions Certificate (LAFC) will be permitted to administer local anesthetics under the indirect supervision of a licensed dentist.
- Kansas: Dental assistants with expanded duties training are allowed to perform coronal scaling above the gum line after completing a Board-approved course.
- Arizona: Senate Bill 1124, signed into law in April 2025, allows dental assistants to become Oral Preventive Assistants (OPAs), enabling them to perform certain preventive procedures after completing specific training.
- Missouri: A pilot program permits OPAs to perform supragingival scaling and polishing on periodontally healthy patients or those with reversible gingivitis, following board-approved training.
- Illinois: Dental assistants with at least 2,000 hours of clinical experience and additional training can perform coronal scaling under the supervision of a licensed dentist.

While these initiatives aim to address workforce shortages and improve access to care, I am concerned about the potential implications for patient safety and the quality of dental care. Procedures like scaling and administering local anesthesia require extensive training and clinical experience to ensure they are performed safely and effectively. Expanding these responsibilities to dental assistants without the rigorous education and licensure that dental hygienists and dentists undergo may compromise patient outcomes.

I urge you to monitor these developments closely and consider their potential impact on our state's dental practice standards. Maintaining high standards for dental care is essential to protect public health and ensure patient trust in our healthcare system.

Thank you for your attention to this matter. I am available to discuss this further or provide additional information if needed.

At each of the hearings family members of deceased patients who were treated with Prozac, Lexapro, Celexa, Luvox, Effexor, Paxil and other SSRI antidepressants testified that the medication caused the patients death as well as other acts of suicide, homicide and violence. They asked that the dangerous drug be removed from the market. Due to heavy pharmaceutical company lobbying and funding the FDA ignored this information and continued approval for SSRI antidepressants.

Members of the public who attended and testified at the hearings were required to sign a waiver stating that they would not play the entirety of the videos of the

hearings. As a result of the FDA's ongoing refusal to include stronger warnings the majority of the public including the doctors do not know that these medications are chemically addictive and cause violent behavior including murder and mass murder. This is Summer Stephan, she is currently the San Diego District Attorney. In 2018 Summer Stephan's office prosecuted Benjamin Lee Bathen, a resident of Springfield Virginia and convicted him of three counts of PC 422 criminal threats for calling the confidential emergency voicemail inbox during a psychotic reaction to the antidepressant Lexapro. The complaint was filed by Dr. Carolyn Francis Jacobs. Dr. Jacobs is the healthcare practitioner who initially coerced Mr. Bathen into taking lexapro. It's illegal for therapists to treat patients with medication in California. Springfield, Virginia is not in immediate proximity to Chula Vista, CA. Nevertheless Summer Stephan's office prosecuted the patient, and refused to charge the doctor for the crimes she committed.

PC 422 Criminal Threats

Any person who **willfully** threatens to commit a crime which will result in death or great bodily injury to another person, with the **specific intent** that the statement, made verbally, in writing, or by means of an electronic communication device, is to be taken as a threat, even if there is no intent of actually carrying it out, which, on its face and under the circumstances in which it is made, is so unequivocal, unconditional, **immediate**, and specific as to convey to the person threatened, a gravity of purpose and **an immediate prospect of execution of the threat**, and thereby causes that person reasonably to be in sustained fear for his or her own safety or for his or her immediate family's safety, shall be punished by imprisonment in the county jail not to exceed one year, or by imprisonment in the

state prison



Springfield, Virginia is not in **IMMEDIATE** proximity to Chula Vista, California. Dr. Jacobs was fully aware of the fact that Mr. Bathen was 2600 miles away from her on the east coast. She also knew that the medication she started him on was causing the incidents. Instead of handling the life threatening adverse reaction she caused appropriately she destroyed or withheld the medical records, lied when presented with the medication, and then demanded five years of prison time, and \$25,000 from the patient she had seriously harmed. Law enforcement will not pursue criminal charges against her, although she clearly did impeach herself and she was illegally treating a patient with medication. Instead opting to cause further harm to a victim of medical malpractice that had no way of knowing not to trust his doctor. Dr. Jacobs did lie under oath, and she is still practicing and causing serious and potentially fatal harm to her patients and herself while law enforcement repeatedly lies, and attempts to conceal, suppress, or discredit [DNA evidence](#).

Dr. Jacobs lied under oath, perjury is a felony that involves willfully lying

under oath. It's defined in California Penal Code Section 118.

Throughout the trial and the pre-trial conference hearings Dr. Jacobs testified that she had to terminate therapy because he relocated out of California and that she referred Mr. Bathen to other local healthcare practitioners in Cambridge, MA. It's illegal for therapists

to treat patients outside of the state they are licensed in over the phone. Dr. Jacobs testimony is false, there was no formal termination of therapy. Instead the telephonic sessions came to a sudden stop because Dr. Jacobs had a psychotic Prozac fueled rage episode in the last therapy session, started screaming like a crazy two dollar hooker for no apparent reason, refused to stop and then abruptly hung up the phone.

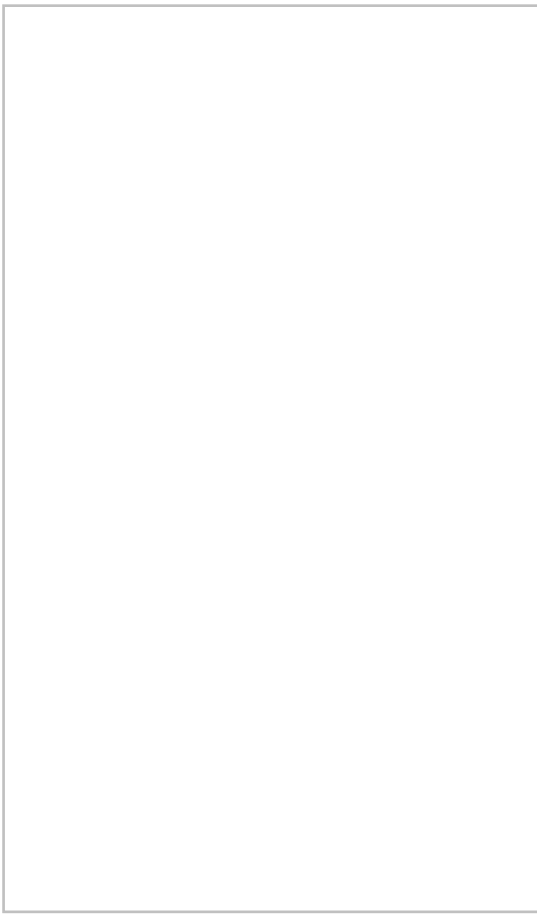


The testimony from Dr. Jacobs is contained in the official state trial transcript, and clearly shows that she lied to the law enforcement community to incarcerate a patient after she gave him permanent brain damage.

The assertions are corroborated by the verified and authenticated email records documenting the scheduling of appointments; however, Judge Stephanie Sontag suppressed the emails and withheld them from the jury's deliberations. While Mr. Bathen was in Boston, MA, and Dr. Jacobs was in Chula Vista, CA, she conducted unauthorized telephonic sessions and intended to continue such practices. Accordingly, she stated, **"Nevertheless, we can continue to make it work!!!"** in the email arranging the final therapy session in September 2008.

The Phone Records show that the last therapy session ended early at 40 minutes instead of the one hour. This is due to the fact that Dr. Jacobs went totally psychotic in the last session and wouldn't stop screaming. Under oath in court she lied to conceal it.

It is illegal for therapists in California, to treat patients with medication. Yet that is exactly what Dr. Carolyn Francis Jacobs did. [In a systematic review of 70 double blind placebo controlled drug trials performed internationally the list of the most serious adverse side effects of selective serotonin reuptake inhibitors includes but is not limited to Homicidal threats, verbally abusive threats, and aggressive threats, as well as inappropriate sexual behavior including both sexual assault and sexual molestation.](#) There is no warning about violence towards others in the 2017 FDA approved medication guide, and the terms Akathisia and Tardive Dyskenisia do not exist in the documentation. It is impossible for any patient to know how badly these drugs will destroy or end their life.

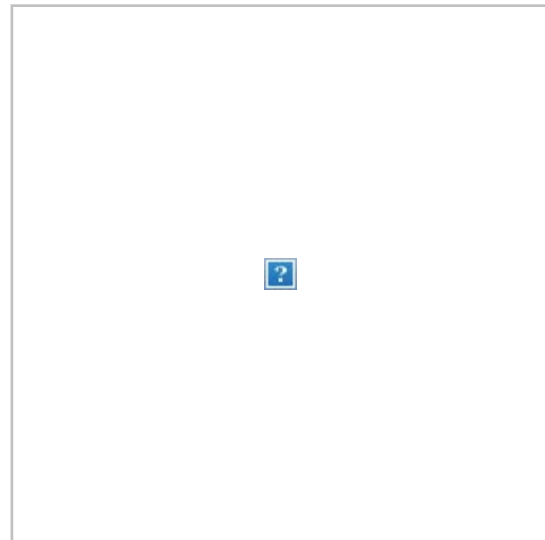
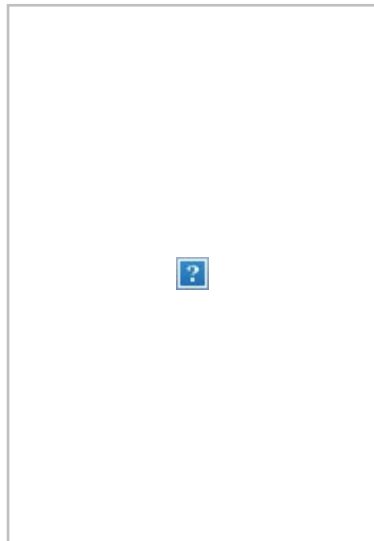

This is James Joel Madero. Mr. Madero is a criminal and a liar. He prosecuted Mr. Bathen based on the complaint from Dr. Jacobs. [Mr. Madero committed prosecutorial misconduct by refusing to disclose the medical records](#), or the fact

that the medication Dr. Jacobs illegally treated Mr. Bathen with medically induces episodes of acute psychosis characterized by extreme acts of violence towards others.

In august of 2024, he admitted in an online web poll that Benjamin Lee Bathen was NOT GUILTY. Rule 3.8 of the bar association 'special duties of a prosecutor' requires that prosecutors who know a defendant was wrongfully convicted, go back and assist in remedying the false conviction. In addition to committing a blatant brady violation, and soliciting false testimony during a triple felony trial, Mr. Madero has taken no steps to correct the false conviction or to hold the real perpetrator accountable.



This is Cherie Brianne Somerville, the assistant district attorney that wrongfully tried and convicted Benjamin Bathen at trial. Cherie Somerville graduated from Whittier law school. Whittier law school was so bad, that the California Bar Association shut them down because there was no real chance that any of the students would move on to successful legal careers. [Both Cherie Somerville and James Joel Madero knowingly withheld exculpatory documents and information from the defense to have a victim of medical malpractice](#) sentenced to two years in an incredibly violent, unbelievably racist state facility. These are some of the judges who issued rulings in the people vs. Bathen and Bathen vs. Allison. The Connecticut medical examiner refused to release the medical records because they said it might "scare patients off from taking their medication" There is a definite correlation between the mass shootings and treatment with selective serotonin reuptake inhibitors. Even though this was one of the most disturbing and fatal mass shootings in the U.S. law enforcement won't hold the doctors, pharmaceutical companies, or the FDA accountable and the FDA won't withdraw approval for the drug.

Joe Schiel was treated with Lexapro. [He developed severe disorientation, cognitive decline, personality change, and leapt to his death from a balcony in front of his severely traumatized wife.](#) Treatment with these substances killed Joe and ruined the lives of his wife and family. Nobody is happy that Joe went slowly insane and killed himself, the doctors know that these types of reactions will occur, and that law enforcement won't hold them accountable for killing innocent people.



During a marital separation Elias Joubran, was treated with generic Lexapro(escitalopram) within 24 hours he became extremely agitated and shot his wife Sheila Joubran in the head before committing suicide by firearm. An ongoing lawsuit alleges that the pharmaceutical company placed an unreasonably dangerous drug on the market that caused this tragic incident. As per usual the judges are lying, dragging their feet and making up ridiculous bullshit instead of preventing future incidents or protecting the public.

Good Morning Councilman Foster,

Thanks for the notice of the draft budget.

Here is what I want to say to the council. Not sure how much I can actually finish.

These days, there are too many funding uncertainties. The State and Feds have huge deficits and we are basically in a rolling recession if not a depression. The Feds already took back \$40 million of approved funds from a grant to the County HHSA. It could happen here too.

But even the city may be counting on money that may not materialize when needed or at all. As a key revenue measure, the Draft Budget assumes implementation of Measure C, a 2020 citizens' initiative to increase the Transient Occupancy Tax. If upheld, Measure C could generate \$192.1 million for homelessness programs and \$276.4 million for the Convention Center over five years.

The General Fund includes important safety items like Police and Fire. Both departments need staffing increases. You need to get your funding secure before budgeting it.

Looks like you do not have an explicit reserve fund. You should have one, especially if your funding is uncertain.

Why are Labor negotiation non-personnel expenses being budgeted as an addition? So you can negotiate at fancy hotels and over wine and boeuf bourguignon instead of donuts?

Tree planting does not seem that important. We have trees. Trees make seeds. Maybe planting seed would be cheaper.

Homelessness spending is good. But they need dignity and substituting porta-a-potties for restrooms crowds the streets and a full restroom with tables would be better.

Why are you spending money on Gun Violence prevention when Gun Violence is down? Gun suicides are on the rise.

Balboa Park is for recreation, not paid parking.

And why don't you cut garbage fees instead of implementing a new bureaucracy to lower them for low-income people?

I'm glad you are reducing personnel expenditures, but I am opposed to cutting Commission on Police Services, Fire-Rescue Services, or Police Reduction in extension of shift and patrol backfill operations overtime.

You do want Parks & Rec brush management in high fire risk areas, which is most of the city.

It is not advisable to cut anything associated with Stormwater.

On the Capital Projects, which you seem to be clamming up about the specifics of, I see you are spending a lot of money on water, probably a lot more than is needed. You need to spend a lot more on drainage and maintenance. You don't want the city to fall apart before you plant trees all over it :-).

From Midway Rising to deferred maintenance, there is a lot of waste.

You should have a public database of contracts so that the public can advise you on how to save money there and stop contract waste, fraud, and abuse.

I hope that my comments done on the quick lead to a better managed city.

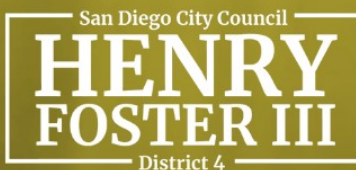

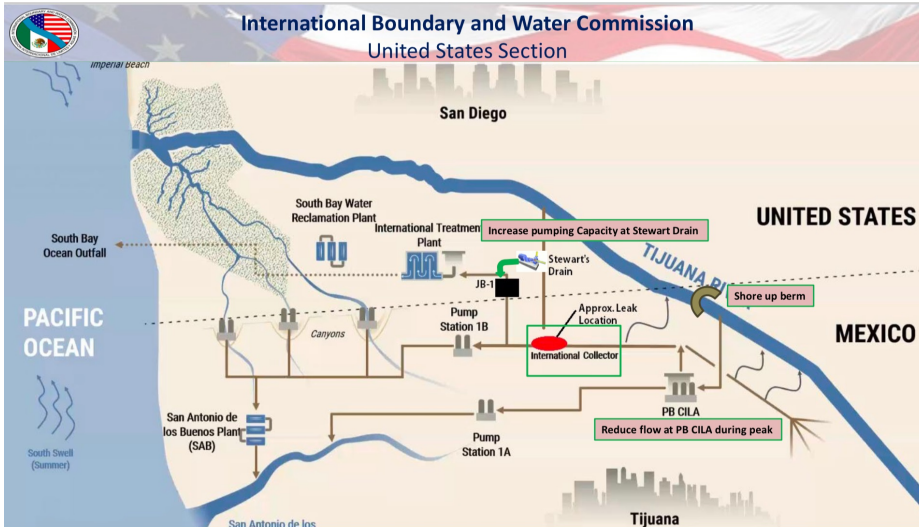

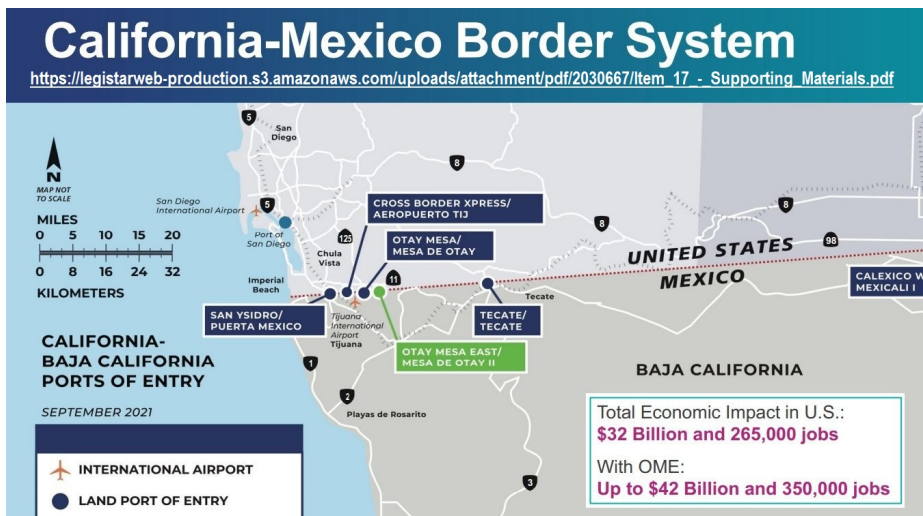

"Researchers studying the health and environmental impacts of the cross-border sewage crisis said Friday they are pulling their teams collecting air and water samples in southern San Diego County communities because of “concerningly high” levels of hydrogen sulfide, a toxic gas. According to emails between researchers from UC San Diego and San Diego State University, the decision came late Friday morning from Kim Prather, director of the Center for Aerosol Impacts on Chemistry of the Environment at UC San Diego and principal investigator on a 2023 study about sewage in waters off Imperial Beach becoming airborne. “As you know, I feel strongly about solving this problem, but cannot in good conscience continue to put my own people at this level of risk,” she wrote to members of a task force studying the impacts of the sewage crisis. Moments later, Prather advised her team to stay in hotels outside South County. Prather said her team, which collects data around the clock, found levels of **hydrogen sulfide** — one of the **main chemical components of sewer gas** — to be persistently and dramatically above the state standard throughout the night and into the early morning hours Friday. The rotten egg odors characteristically associated with the gas were especially unbearable Thursday, according to her team and numerous reports from the public, who said **odors infiltrated their air conditioners and their carbon monoxide alarms went off late at night or early in the morning.**"

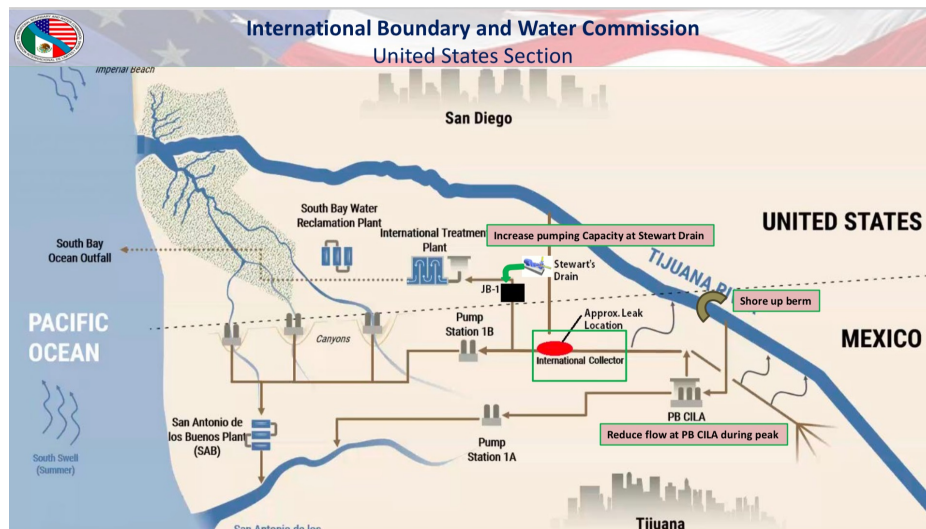

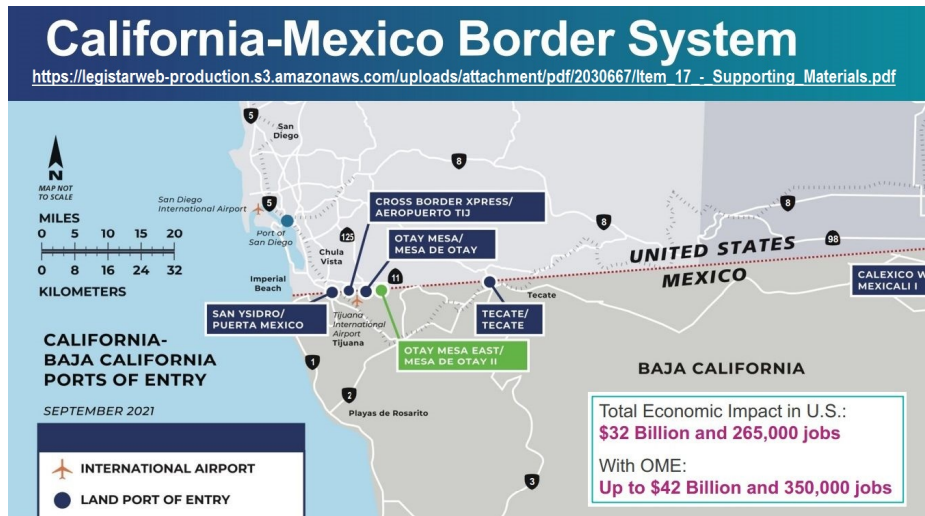

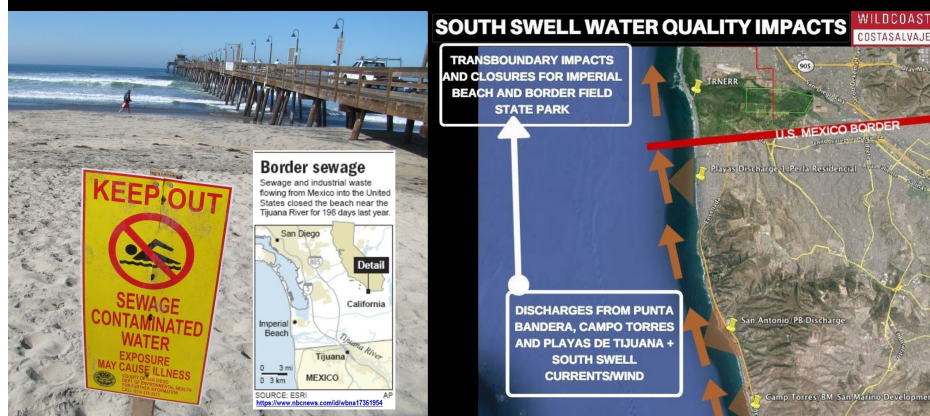

"Researchers studying the health and environmental impacts of the cross-border sewage crisis said Friday they are pulling their teams collecting air and water samples in southern San Diego County communities because of "concerningly high" levels of hydrogen sulfide, a toxic gas. According to emails between researchers from UC San Diego and San Diego State University, the decision came late Friday morning from Kim Prather, director of the Center for Aerosol Impacts on Chemistry of the Environment at UC San Diego and principal investigator on a 2023 study about sewage in waters off Imperial Beach becoming airborne. "As you know, I feel strongly about solving this problem, but cannot in good conscience continue to put my own people at this level of risk," she wrote to members of a task force studying the impacts of the sewage crisis. Moments later, Prather advised her team to stay in hotels outside South County. Prather said her team, which collects data around the clock, found levels of **hydrogen sulfide** — one of the **main chemical components of sewer gas** — to be persistently and dramatically above the state standard throughout the night and into the early morning hours Friday. The rotten egg odors characteristically associated with the gas were especially unbearable Thursday, according to her team and numerous reports from the public, who said **odors infiltrated their air conditioners and their carbon monoxide alarms went off late at night or early in the morning.**"

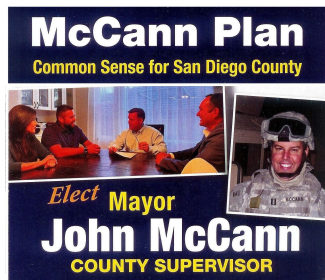
