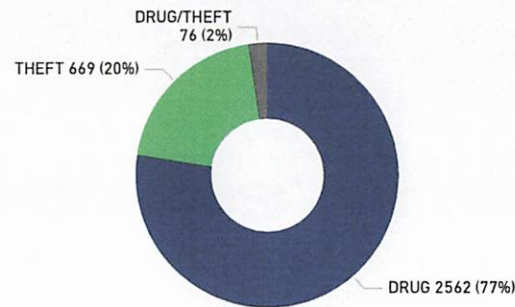

Prop 36 Charge Category



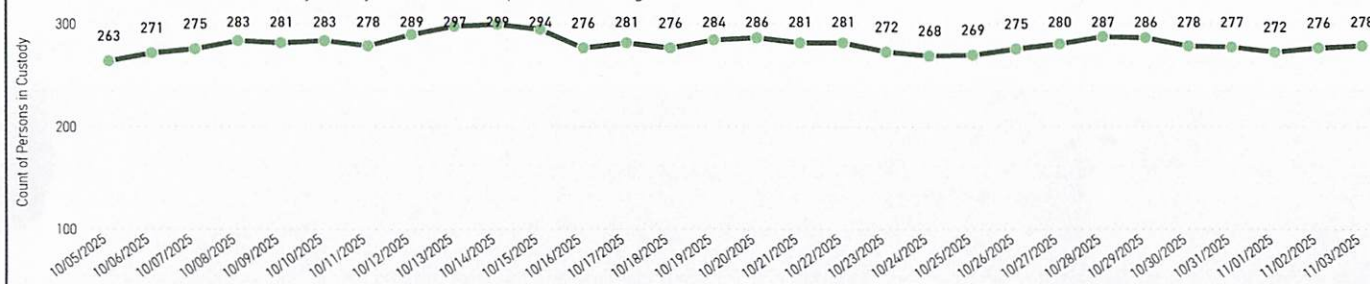

Count of Incarcerated Persons In Custody Per Day with an Active Prop 36 Related Charge*



*Average Daily Population is based on a snapshot taken of the in-custody population each day at midnight. This represents the number of individuals in custody that have a Prop 36 charge that is still pending a case disposition or completion. Individuals with a final disposition entered for a Prop 36 charge who are in custody for any other active charge(s) or arrest(s) unrelated to Prop 36 are not included in these counts.

**This represents a distinct count of arrests by arresting agency. A single booking may be comprised of multiple arrests, arresting agencies, and arrest types (e.g., field arrest, warrant, remand, supervision violation, etc.). Therefore, the sum of rows may not add up to the distinct booking total as one booking can have more than one arrest where a Prop 36 charge was present.
