RE: Setting the Annual Fee for the Tobacco Retail Licensing Program

Dear Chair Fletcher and Members of the San Diego Board of Supervisors:

The American Heart Association supports comprehensive Tobacco Retail License (TRL) programs as an evidence-based strategy to reduce youth tobacco initiation, access, and use. We urge the Board to approve the proposed annual TRL fee that will cover the full cost of the program and ensure retailers are not selling tobacco to youth.

Today, over 30% of high school students use tobacco and easy access to tobacco products is driving these numbers. Youth under the age of 21 are often able to purchase tobacco products at all types of retailers including convenience stores, gas stations, and grocery stores.

San Diego County's TRL program was enacted in 2020 to address this problem. The program allows the County to monitor local tobacco retailers, conduct enforcement to ensure compliance with local, state, and federal laws, and penalize retailers who sell to minors. Central to a TRL is an annual fee on all retailers that covers the cost of program administration and enforcement. This is the only sustainable way the County can fund enforcement of the minimum legal sales age.

Robust TRL programs also help reduce health disparities. Tobacco retailers cluster in low-income neighborhoods and Communities of Color, particularly communities with higher proportions of African American and Hispanic residents. This fuels disparities in tobacco use and its deadly health effects. Evidence shows that these communities have higher rates of tobacco use and addiction, worse health outcomes, and increased health inequities. Fully funding the County's TRL program will ensure stores in all neighborhoods do not sell tobacco to youth, a critical strategy for protecting our most vulnerable residents and reducing socioeconomic disparities.

Over 130 California communities protect their kids from nicotine addiction by licensing their tobacco retailers. We urge you to stand by the County's strong TRL program and support an annual fee that covers the full cost of the program.
