ORDINANCE NO. 10958 (NEW SERIES)

ORDINANCE ADDING SECTION 72.169.90., AMENDING SECTIONS 72.164.5., 72.162.21., AND 72.169.74.5., AND DELETING SECTION 72.169.74.6. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.90. of the San Diego County Code is added:

SEC. 72.169.90. ALPINE. The prima facie speed limit on Alpine Boulevard between the easterly line of Arnold Way and the westerly line of Tavern Road is hereby decreased to and established at 50 miles per hour.

Section 72.164.5. of the San Diego County Code is amended:

SEC. 72.164.5. BONITA. The prima facie speed limit on Mesa Vista Way and Bonita Mesa Road between the southerly line of Sweetwater Road and the city limit of National City (west of Putter Drive) is hereby decreased to and established at 35 miles per hour.

Section 72.162.21. of the San Diego County Code is amended:

SEC. 72.162.21. FAIRBANKS RANCH. The prima facie speed limit on San Dieguito Road from the north line of El Apajo northerly to the San Diego city limit (east of Circa Oriente, private road) is hereby decreased to and established at 45 miles per hour.

Section 72.169.74.5. of the San Diego County Code is amended:



Section 72.169.74.6. of the San Diego County Code is hereby repealed and deleted.


