This is to advise that the San Diego County Board of Supervisors has approved the above-described project on July 16, 2024 (#) and found the project to be exempt from the CEQA under the following criteria:

This lease amendment is categorically exempt from CEQA pursuant to Section 15301, Existing Facilities as it involves amending an existing lease for use of warehouse space in an existing facility that involve no expansion of the existing or former use of the building. Further, no exceptions listed in CEQA Guidelines Section 15300.2 apply to the project. Additionally, the project will not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; will not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; and is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code.
