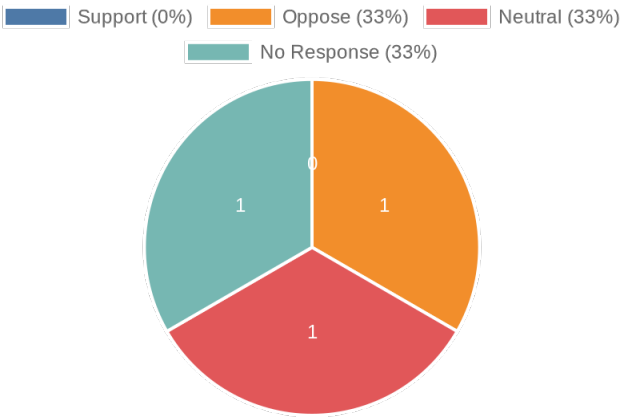

Overall Sentiment

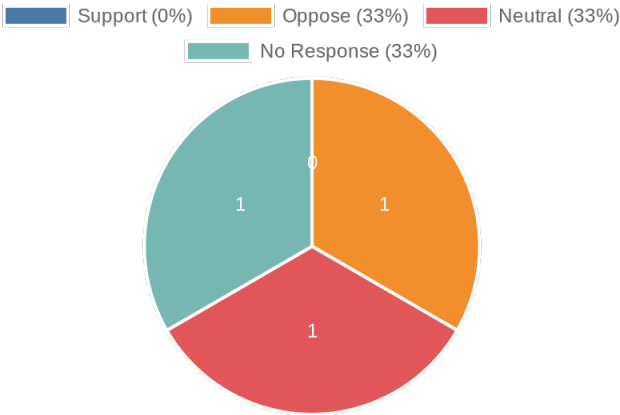

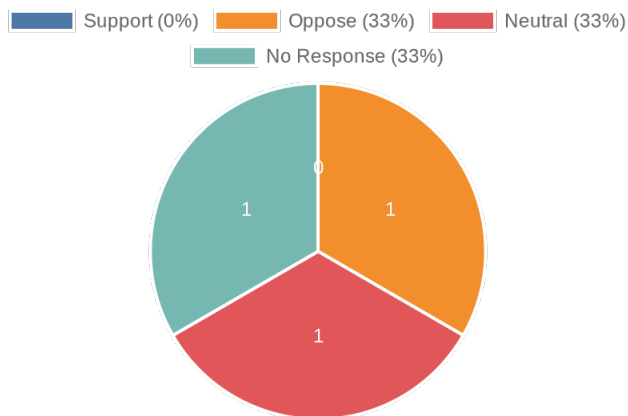
