A Deputy Sheriff in patrol, the courthouse or in a detentions setting may be equipped or have access to an irritant filled launcher (Pepperball), 40 mm launcher and/or less lethal bean bag shot gun.

Law Enforcement, Detentions/Courts Deputies and Search and Rescue volunteers are authorized to operate the Unmanned Aerial Systems (UAS) after completing mandatory training.

The remaining listed equipment, apart from items mentioned above listed in this document is primarily used by the Sheriff's Special Enforcement Detail (SED) during a critical incident or tactical operation. These incidents are mission based and may only call for some of the items to be used. Our goal is to resolve these incidents in a manner that will best safeguard the public's welfare, safety, civil rights, and civil liberties. The attempt to resolve each incident without using force or using as minimal force as possible is our primary goal.

A tactical operation or critical incident may be considered as, but not limited to the following:

It is the policy of the San Diego Sheriff's Office to ensure we provide adequate public safety services in a transparent manner, including the purchase and use of military equipment. Decisions regarding the use, procurement and funding of military equipment should take into consideration the public's welfare, safety, civil rights and allow for public input.

The Sheriff's Office shall make the following considerations before seeking authorization for purchasing military equipment:

- The equipment is necessary because there is no reasonable alternative that could provide the same objective of deputy and civilian safety.
- The equipment is reasonably cost effective compared to alternatives that can achieve the same objectives of deputy and civilian safety.

The procurement or use of any new type of military equipment, not already in possession of the Sheriff's Office, or approved on the current Military Equipment Policy, will require the approval of the County Board of Supervisors as outlined in Section 7071(a)(1)(A) - 7071(a)(1)(G). These procedures are also outlined in Sheriff's Policy and Procedure Section 6.4.

San Diego Sheriff's Office Policy and Procedure Section 6.4 Military Use Equipment may be referred to for additional information regarding:

- The definition and types of military equipment as defined in California Government Code section 7070(c)(1) - (16).
- The approval process for the purchase of any additional military equipment.
- The requirements for the annual review of the Military Equipment Report as defined by California Government Code Section 7071(e).

The San Diego Sheriff's Office is subject to independent oversight by the San Diego County Grand Jury, as well as the San Diego County Citizen's Law Enforcement Review Board. Additionally, the actions of peace officers may be subject to review for violations of California law by the San Diego County District Attorney's Office, and the California State Attorney General's Office. Additionally, the U.S. Attorney has the ability to investigate and prosecute for violations of federal civil rights laws under color of authority.

Violations of the Military Equipment Use Policy by members of the Sheriff's Office may result in sanctions including suspension or termination.

Formal complaints, warranting further investigation, will be routed to Internal Affairs for review and follow-up, in accordance with statute and policy. The Sheriff's Office will investigate any noncompliance with the Military Equipment Use Policy in accordance with section 832.5 of the California Penal Code, which sets mandatory provisions for complaints made on peace officers as defined by California Penal Code 832 and custodial officers as defined by section 831.5 PC.

The SED Lieutenant in collaboration with the Division of Inspectional Services will conduct annual inspection to ensure the Military Equipment Use Policy is followed and the items listed in the Military Equipment Report are utilized within policy and in accordance with applicable laws. Any violation of policy or law will be investigated accordingly and reported in the annual Military Equipment Use Report.

During this year, interior drones and surveillance robots were used by the Sheriff's Special Enforcement Detail during high-risk warrant services, tactical operations, and training operations. These remote piloted devices were used to inspect confined areas that were deemed too unsafe to for law enforcement personnel to inspect in person.

14.1.5 – Bomb Squad Robots

During this year, Bomb Squad robots were used by the Sheriff's Bomb/Arson Unit during investigations of suspicious devices and explosive ordinances, high-risk warrant services, tactical operations, and training operations. These remote piloted devices were used to inspect confined areas and suspicious devices that were deemed too unsafe to for law enforcement personnel to inspect in person.

14.2 – Armored Personnel Carriers/Multipurpose Wheeled Vehicles

During this year, the Sheriff's Office's Special Enforcement Detail and Bomb Arson Unit

14.4 – Specialized Firearms/Ammunition Less Than .50 Caliber

14.6 - Chemical Agent, Pepper Spray, Oleoresin filled projectiles (Pepper Balls), Specialty Less Lethal Munitions, Flashbang grenades

This year the Sheriff's Office used Chemical Agents, Pepper Spray, Oleoresin filled projectiles (pepper balls), Specialty Less Lethal Munitions and Flashbang grenades as de-escalation tools to safely resolve critical incidents.

14.7 - 40mm launchers, Less Lethal Bean Bag shotgun and munitions

This year the Sheriff's Office used 40mm launchers, Less Lethal Bean Bag shotguns and ammunition as de-escalation tools to safely resolve critical incidents. These items were also used during training exercises.

14.8 – Long Range Acoustic Device (LRAD)

The Sheriff's Office used LRAD's during Mobile Field Force training exercises. The LRAD was used as a voice amplification device, similar to a megaphone to assist with communications.
