NOTICE IS HEREBY GIVEN that the Board of Supervisors of the County of San Diego will consider for adoption:

AN ORDINANCE AMENDING THE COUNTY CODE OF ADMINISTRATIVE ORDINANCES RELATING TO EMPLOYMENT ON COUNTY CONSTRUCTION PROJECTS AND PROPERTY AND ESTABLISHING A WAGE FLOOR

This ordinance would amend the County Code of Administrative Ordinances to require that contractors on County construction projects over \$1,000,000 utilize a skilled and trained workforce and provide their employees paid time off for absences due to medical and other specified conditions. It would also require that lessees of County-owned property pay construction contractors on projects over \$1,000,000 prevailing wages, pay their employees and contractors no less than a wage floor set by the County, and provide their employees and contractors time off for absences due to medical and other specified conditions.

The proposed ordinance will be presented to the Board of Supervisors for the first reading on February 8, 2022, at which time public testimony will be received. The Board meets at 9:00 a.m., in Room 310, County Administration Center, 1600 Pacific Highway, San Diego, California. Interested persons are encouraged to review the text of the proposed ordinance in detail.
