



### Overall Sentiment



This is essentially bribery in the Sheriff Department. Vote no.

The ordinance, Section 66.1 and .4 would allow the Sheriff to get money or assets seized by Fed agencies (ICE, BPS, FBI, etc.) and then says that is essentially a bribe to ensure co-operation with them. It specifies that "The Program's purpose shall be to provide an added incentive to the Sheriff's Office to join with Federal, State and other local law` enforcement agencies to stem the rising tide of crime..." And then, the audit is yearly, so we might not find out about improper use for a year or more. That is, they could arrest someone and sell off their heirlooms almost with impunity. The amendments for recommendation 1 part 2 should be attached. This is a public proceeding. Using language like 'such as...' or descriptions rather than specifics are not acceptable.

Closing down the courthouse construction fund completely is a bad idea. The inside is shabby. There will always be a need.
