SPEAK ON: 04/22/2025

① — THANK YOU MR. SPEAKER... MAYOR CLORIA... CITY COUNCIL MEMBERS AND CITIZENS OF SAN DIEGO. I JUST NEED 3 MINUTES OF YOUR TIME AND I WILL READ THIS FOR BREVITY AND ACCURACY.

— ON JUNE 7TH 2023... I WOKE UP FROM A VISION TO BOTH A SOLUTION AND EXIT STRATEGY TO SAN DIEGO CITY AND COUNTY HOMELESSNESS.

— AND LET ME SAY WHETHER WE EMBRACE THIS SOLUTION AND EXIT STRATEGY NOW... IT WILL BE NECESSARY TO IMPLEMENT IN THE FUTURE AS HOMELESSNESS ENCAMPMENT GETS WORSE AND WORSE... MARK MY WORDS.

— YOU SEE RIGHT NOW WE MAY HAVE AS MANY AS 35-40,000 PLUS HOMELESS IN OUR CITY AND COUNTY. WE HAVE PEOPLE IN PARKING LOTS HERE... PARKING LOTS THERE, HOTELS HERE... MOTELS THERE... SIDEWALKS... STREETS... CANYONS AND CAL TRANS; HILLSIDES.

— YOU SEE THERE'S NO ACCOUNTABILITY IN ALL THIS MESS. THOUGH THERE ARE MANY HOMELESS PEOPLE ON DRUGS ACTING CRAZY OUT THERE... WE STILL HAVE MANY PEOPLE HOMELESS WHO WANT TO GO BACK TO WORK. WE HAVE TONS OF SERVICE JOBS JUST WAITING FOR WORKERS AT 20.00 AN HOUR. BUT WITH EVERYBODY, HOMELESS SCATTERED ALL OVER THE PLACE, THERE'S NO ACCOUNTABILITY FOR COUNSELORS TO REALLY HELP MULTIPLE PEOPLE AT ONCE WITH INFORMATION AND JOB APPLICATIONS.

② - NOW... THIS PLAN CALLS FOR THE SAME ②
FEDERAL, STATE, LOCAL AND DONATION DOLLARS
WE'RE USING NOW TO COMBAT HOMELESSNESS.
IN FACT, ONCE THIS PLAN IS IMPLEMENTED WE
WILL EVEN USE LESS MONIES OVERALL THAN NOW.

- HERE IS THE PLAN AND EXIT STRATEGY
SOLUTION TO ALLIEVIATE AND ELIMINATE HOMELESS
ENCAMPMENT AND TO EMPLOY ACCOUNTABILITY
LEADING TO AN EXIT STRATEGY. IT WILL BE TO
BRING EVERYBODY TO "THE CITY OF HOPE". IT WILL
BE LOCATED ON 425 ACES IN "SOUTHEAST OTAY".
IF YOU RECALL... 4025 YEARS AGO THE FEDERAL
GOVERNMENT TRANSFERRED 600 ACRES TO SAN DIEGO
AS PART OF THE "BORDER WALL SWAP". WE ALSO
HAVE MANY ADDITIONAL BLOCKS OF LAND THAT
COULD BE UTILIZED FOR THIS 425 ACRE BLOCK.
 - AGAIN WE WILL USE THE SAME FEDERAL, STATE,
LOCAL AND DONATION DOLLARS WE ARE SPENDING
NOW... AND ONCE "CITY OF HOPE" IS SET UP... I
BELIEVE WE WILL BE USING LESS MONIES OVERALL.

- I DID THE CALCULATIONS... 425 ACRES CAN
HOUSE 40,000 10X10 TENT SLABS WITH 10 FOOT
PERIMETER SETBACKS BETWEEN EACH TENT. EACH
STANDUP TENT WILL BE EQUIPPED WITH AIR MATTRESS...
SMALL TABLE AND 1-3 CHAIRS. IF WE DON'T DO TENT
SLABS WE CAN BUILD BASIC BUILDINGS TO HOUSE PEOPLE.
"CITY OF HOPE" WILL NOT BE ANY TYPE OF UNCONSTITUTIONAL
MANDATORY STAY. PEOPLE MAY COME AND GO AS THEY
WISH. BUT... WHY WOULD THEY WHEN THEY RECEIVE
2 MEALS A DAY... CLEAN SHOWERS WITH PORTABLE
TANKS AND CLEAN PORTABLE TOILETS. IT'S GOING TO BE
SOO MUCH BETTER THAN COLD STREETS AND CANYONS

③ — WITH TRASH SURROUNDING THEM AND ^{ALL} OTHER UNSANITARY CONDITIONS. SO... PEOPLE CAN LEAVE, BUT IF THEY ENAMP IN THE CITY OR COUNTY ~~INCLUDING~~ CALTRANS HILLSIDES... THEY WILL BE ARRESTED AFTER 3 STRIKES. THEREFORE, "CITY OF HOPE" WILL BE SOO MUCH MORE ATTRACTIVE FOR PEOPLE TO STAY UNLESS THEY COME AND GO FOR WORK.
