RE: Agenda Item #11, October 21, 2025 – Authorization to Negotiate Purchase of Property for the Troy Street Sleeping Cabins Project and Adoption of a Resolution Declaring the Land Will be Used for a Public Purpose - **SUPPORT**

Dear Chair Lawson-Remer and Members of the Board of Supervisors:

The League of Women Voters of San Diego and the League of Women Voters of North County San Diego support actions to finalize the project of the Troy Street Sleeping Cabins backed by the League of Women Voters of California's position on Meeting Basic Human Needs.

The League's support of this item follows our support in July 2024 when we cited the County's responsibility to provide for the needs of people experiencing homelessness throughout the unincorporated area. At that time, we noted the County's resourcefulness in quickly identifying, evaluating and accommodating Troy Street as a second-choice option, including the financial alternatives, is in keeping with the crisis our area is facing.

In light of the Federal Highway Administration's withdrawal of approval for Caltrans to lease this property for this purpose, we again support the County's response by declaring the property will be used for a public purpose and to begin negotiations to purchase the land.

This plan meets the County's responsibility to advance compassionate solutions for people experiencing homelessness.

This is already a budgeted item in the County Budget.

We urge the Board of Supervisors to declare the land to be used for public purposes so the Troy Street Sleeping Cabins project can advance. There is no need more basic for humans than safe shelter.
