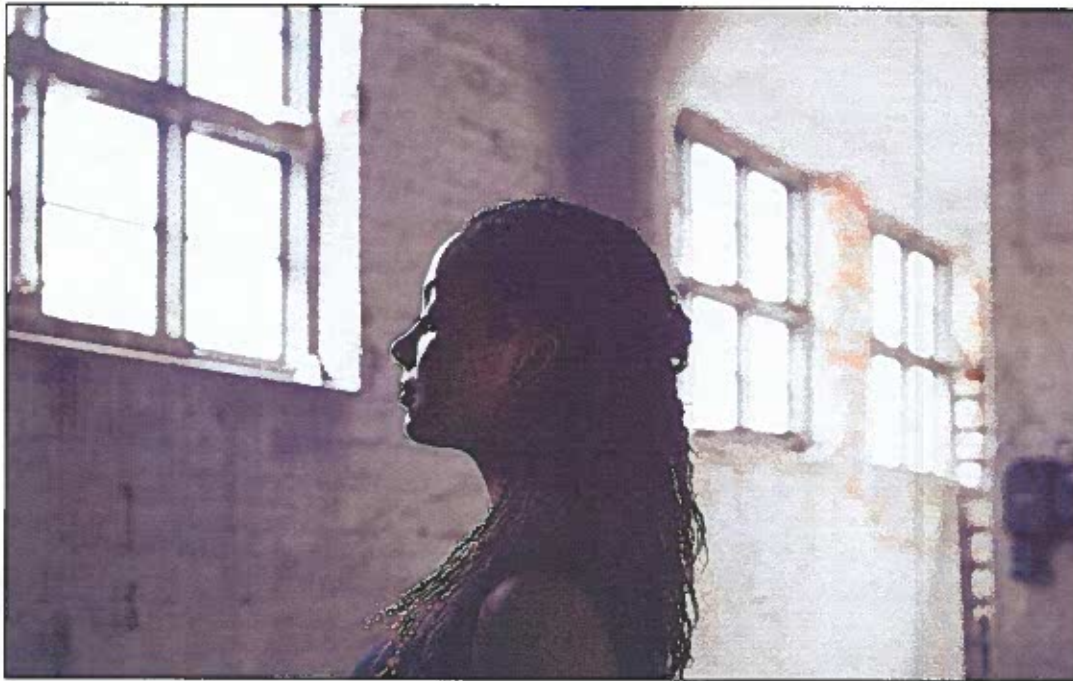

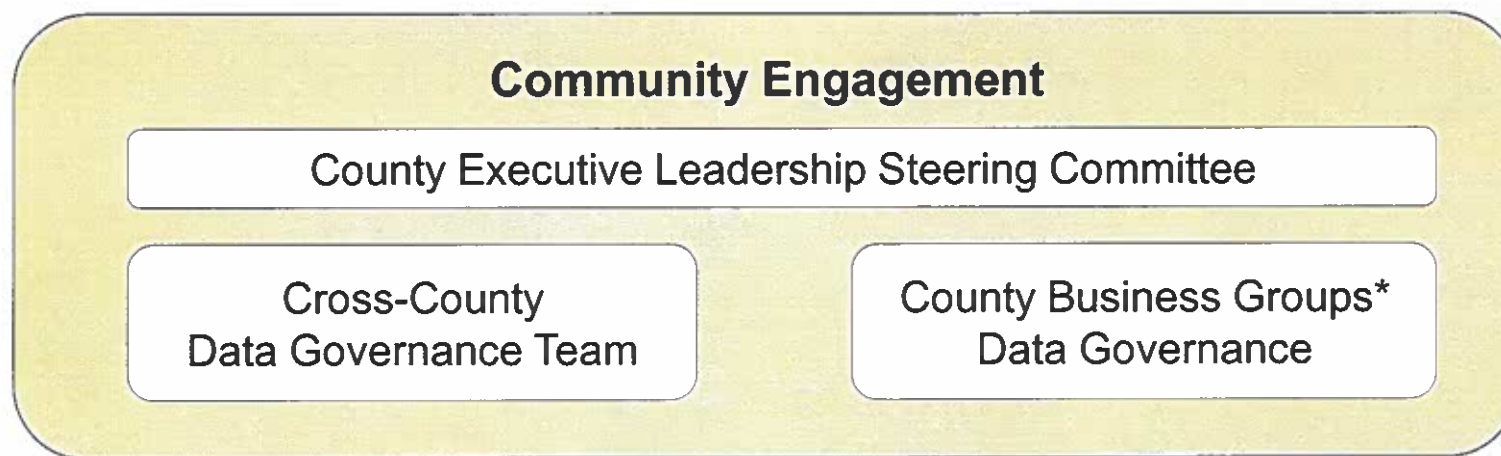

21. CARE COORDINATION FOR JUSTICE-INVOLVED INDIVIDUALS: DATA GOVERNANCE AND INTEGRATION

This item is an essential aspect of the ATI initiative. Specifically for Intercept 0-1, I hope the scope of the data governance structure and the definition of justice-involved individuals will include those who are involved with 911 calls that involve an apparent behavioral health crisis. Ideally, data from 988 and the Access Crisis Line should be included in this system. Assessing the impact and effectiveness of the Mobile Crisis Response Team program will require law enforcement jurisdictions to provide anonymous data on all 911 calls screened for possible referral to the MCRT or PERT. The standardized data request process must include BHS access to 911 dispatch data which can then be linked with BHS data systems.

Please direct staff to give immediate, not long-term, priority to integrating region-wide 911 call data to document referrals to law enforcement, MCRT, or PERT. Data regarding how each potential MCRT call is assessed using the six screening criteria will be essential to see if, in fact, calls are properly referred. Data should also be available to show specifically what happened for each MCRT referral, from decisions made in the field to ultimate completion of behavioral health services. And please have staff ensure that outcomes, not just outputs, are evaluated.

Many of us in the community have particular concerns about behavioral health services in the jails. For cases that do end up at jail intake, the data system should include data on assessments of all intakes by licensed clinicians and data on behavioral health services and decisions while a person is incarcerated. Of course, these data should be linked to data in other systems which then receive referrals from the jails.

Community Engagement Opportunities should go beyond simply educating stakeholders and seeking feedback. Formal community engagement mechanisms should be designed into all aspects of this process.
