

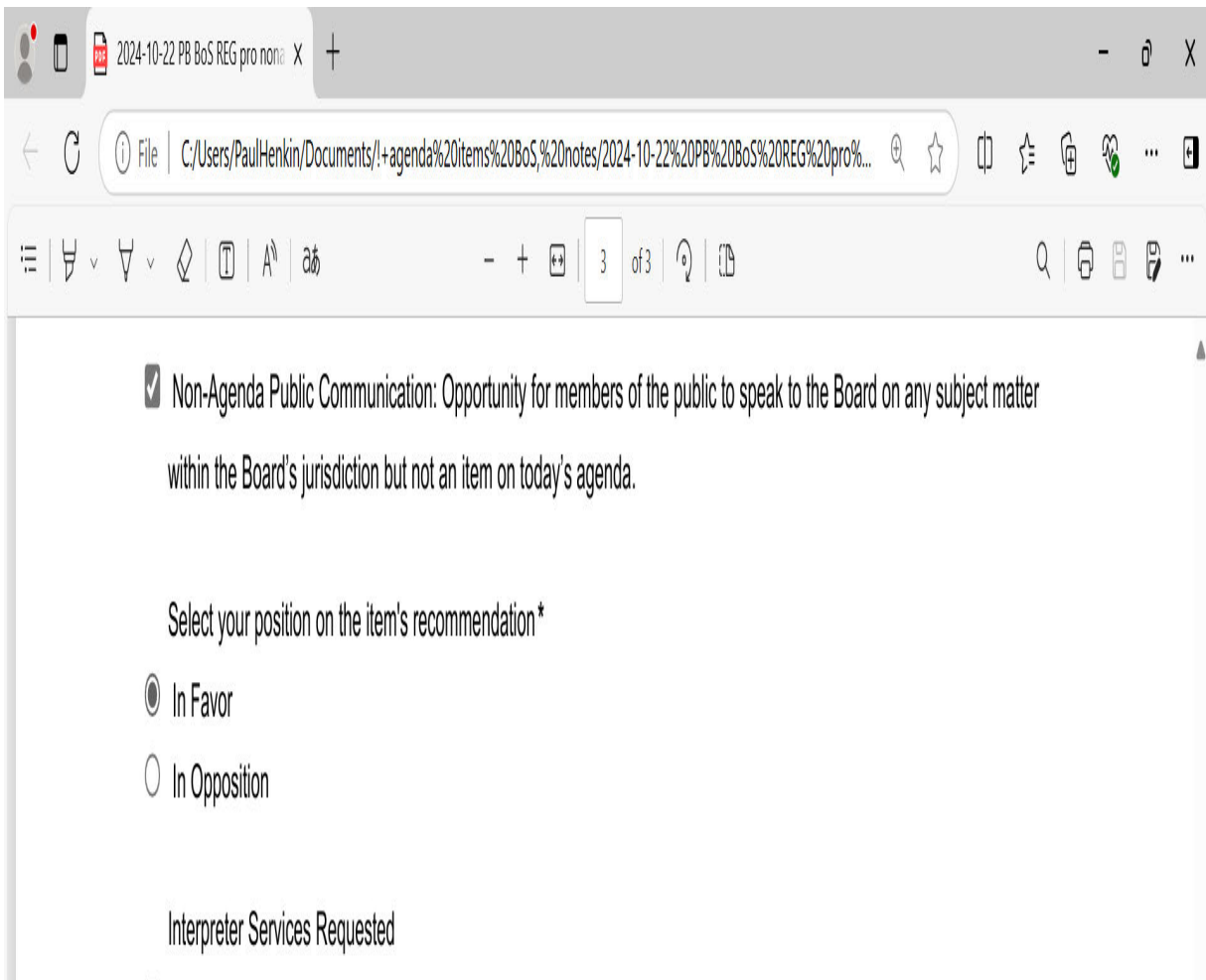

Let's try again. Apologize for the blank message earlier.

Hi Supervisors,

You may have heard Mayor Gloria's press conference announcing the replacement of shelter beds closing at the end of the year. Ordinarily, the replacement of shelter beds is a good idea except that moving the homeless around is not a solution. I fear that this may end up driving more homeless people around to other cities or areas of the County.

From what I heard on KGTV (ABC news10 San Diego, the city's plan is to 'replace' 614 shelter beds that "go offline" by the end of this year with 593 beds. I thank the people who are creating or offering the beds for their generosity. But this does leave out 21 people at least.

165 of the beds are in the Veteran's Village, hopefully available to anyone; 56 are in a Substance Abuse Shelter (hopefully there are that many Drug users to fill the shelter, because not everyone would want to say there); 32 at the SD Rescue Mission; 235 at the Safe Sleeping Sites which the State does not consider shelters; and 105 are at a former motel site probably not available until next year.

So, of the 126 people who won't have beds right away, and however many of the 235 who reject the safe sleeping sites for a real shelter, where will they end up?

We all need to work together to solve this homeless crisis, not bits and pieces, but a co-ordinated plan.

Dear Editors,

Just got another flyer for the misguided Measure G, the ½ cent SANDAG sales tax. This one boldly asks 'had enough potholes?' I'm sure we all have, but with the 7% of the money dedicated to roads maintenance, don't expect them to disappear soon.

The County estimates that the sales tax raised \$5.1 million in FY 2022/23. Another ½ cent, 5% of that, would be \$255 thousand. I've seen a \$350 thou estimate. 7% would be..well, peanuts.

And don't expect State or Fed matching dollars soon, since both are basically broke. The Feds haven't yet fixed the IBWC sewage plant in the TJ River Valley, broken for over 30 years!

Measure G might have a list of projects in the voter guides as if it were set in stone. Most measures do. This tax is a **general tax. SANDAG can legally spend it on whatever it wants, not just the listed projects.** Several promises from previous SANDAG tax measures are unfulfilled.

As of Jan. 2023, these included widening Interstates 5, 8, 15 and 805 and Highways 52, 56, 67, and 78.

The article says that Measure G's backers claim the oversight committee the measure creates will conduct annual audits and it can refer individuals for criminal prosecution if funds are misused. There have been plenty of scandals already and several audits but no-one has been referred for prosecution as far as I know, although anyone can refer. Most of the oversight committee are SANDAG people anyway, so what will be new?

PARTIAL SUMMARY OF SANDAG SCANDALS

- 1- 2004 - Staff lied about financial records to justify a proposed tax increase.
- 2 - 2017 - Staff altered financial records to justify a proposed tax increase.
- 3 - 2019 - CEO Awarded Staff Bonusses without asking the Board of Directors
- 4 - 2022 - Staff used improper perks on business trips, non-business expenses.
- 5 - 2022 - Payouts on contracts were increased improperly
- 6 - 2022 - Contracts awarded without amounts, signatures
- 7 - 2023 - SR-125 toll system, payer accounts wrong 6 yrs. - Board not told until 2023.

The tax increase will hurt residents already burdened by the high costs of living in San Diego County. The current FBI investigation won't help SANDAG's or the County's image either. Keep feeding SANDAG money like a spoiled child and you can bet he or she will only ask for more. And waste it.

Subject: [External] LITHIUM BATTERY STORAGE IN ALPINE? NO WAY

Hi All,

I heard that now the Battery Storage Facility (BESS) people want to put one in Alpine, so let's get the conversation going...

BESS Battery Storage in a wildfire zone is the silliest idea I've heard of for a while. EV's aren't a great idea in these zones either. Here are some of my thoughts on this:

Lithium – used in EV batteries – unstable metal – causes spontaneous fires, repeat, spontaneous, you can't put out, toxic fumes, mass evacuations, oh, and the fire just reignited draining fire department resources. And the response from the Big-BESS-Biz better technology. **Isn't that what they said about the Titanic?**

The Battery Storage (BESS) fire in Otay Mesa (southern San Diego County) burned for about a week. Firemen were monitoring it even longer instead of being elsewhere, and they evacuated people within a mile.

There are proposals for larger BESS facilities in San Marcos and Poway near a major hospital, school, and residences, within a few hundred yards in San Marcos and 1/2 mile in Poway. Lithium ion batteries put out toxic fumes like **phosphorous pentafluoride** and are a **huge wildfire hazard** and would **draw away fire dept resources** to monitor fire for weeks.

I wrote this about the big SOCAL wildfires in August/September. I think that lithium-ion batteries and BESS made them alot worse:

The SOCAL weather has been noticeably cooler for a few days. You would think that this would help the wildfire control. Yet this morning, September 14th, the three big California wildfires near Los Angeles and Orange County, are still raging virtually uncontained: the Bridge fire at 53K acres, 3% containment; the Airport fire at 23K acres, 9% containment; the Line fire at 38K acres, 25% containment.

Temperatures for 9/11 in San Dimas (Bridge fire) got down to the upper 50's; San Bernardino (Line fire) and Rancho Santa Margarita (Airport fire) got down to the 60's.

These fires should be on the way out. It is time, maybe past time, to study whether electric vehicles (EV's) and battery storage facilities (BESS) are contributing to the fires' staying power, especially with lithium's ability to spontaneously combust multiple times.

And by the way, it should tell you something that the arsonist who started the huge 400K acre Park fire in Northern California used an EV to start it.

Moments later, Prather advised her team to stay in hotels outside South County. Prather said her team, which collects data around the clock, **found levels of hydrogen sulfide — one of the main chemical components of sewer gas — to be persistently and dramatically above the state standard throughout the night and into the early morning hours Friday**. The rotten egg odors characteristically associated with the gas were especially unbearable Thursday, according to her team and numerous reports from the public, who said **odors infiltrated their air conditioners and their carbon monoxide alarms went off late at night or early in the morning**."

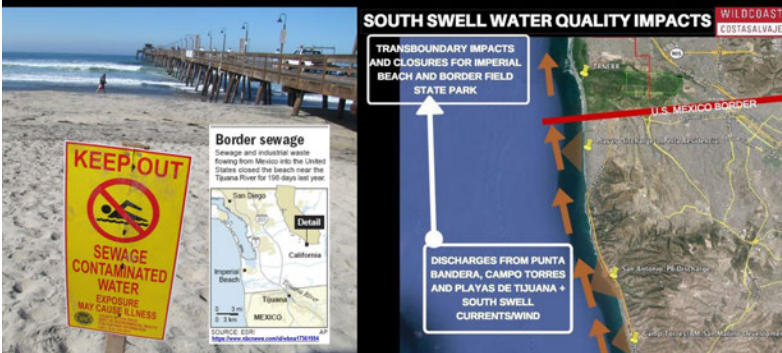



New tool tracks how much hydrogen sulfide South Bay residents are breathing

Story by Alex Lai [11-17-2024]

The recognizable sewage smell in the South Bay is hydrogen sulfide gas. It can cause headaches, lung irritation, nausea, dizziness, vomiting and is linked to **serious long-term health issues**.

And speak of misconceptions, I can see one right off the bat – why are the spikes so much higher in Nestor (2-1/2 miles from the border) than San Ysidro (1-1/2 miles) if this is coming from Mexico? (For instance, 24.5 PPB at

Nestor on 11/16/2024 8pm versus 0.1 ppB at San Ysidro.)

San Diego County's Air Pollution Control District launched a website showing hydrogen sulfide levels detected in Nestor and San Ysidro. There are currently two air quality monitoring systems, one at Berry Elementary School in Nestor and another at the San Ysidro Fire Station 29.

"This new dashboard provides historical data for the last week, and that is updated on a daily basis," Air Pollution Control Officer Paula Forbis said. "And in addition to that, there's a button, a clock icon, that people can click to get hourly data that is updated every hour."

Hydrogen sulfide readings are measured by parts per billion, or ppB, and are divided by an odor advisory system. One ppB is equivalent to a single drop of water in a 10,000 gallon pool.

Green means 0 to 4.9 ppB of gas is detected. There's usually no symptoms or smell associated.

Yellow is 5 to 29.9 ppB. Sensitive groups may notice the smell at this level.

Orange is when the ppB hits 30 or higher.

"It's a level at which the vast majority of the public will smell the odors and a large percentage made bothered by them," Forbis said.

The most extreme level is purple, at more than 27,000 ppB detected, which would require emergency response.

An odor advisory will be sent to the public with safety recommendations,

including staying indoors, closing windows and using air purifiers. You can sign up for odor advisory alerts here.

"Our role is really to focus on monitoring for air quality and providing that information to the appropriate public health authorities if we start to see levels of hydrogen sulfide get really elevated," Forbis said.

In a few weeks, another monitoring system will be place at the Imperial Beach Civic Center.

"We're also obtaining funding for a mobile monitoring van that will be able to supplement these three stationary monitors with an instrument that can provide instantaneous read of hydrogen sulfide," Forbis said.

Plans are also in the works to provide some South Bay residents with air purifiers.

Dear Sir/Madam:

The toxic gases from any lithium fire are dangerously hazardous to our health. These facilities must not be placed in locations where people and animals will be subject to exposure. I'm not convinced there are any best practices for a lithium battery storage facility given the toxicity, but since you may consider me nothing more than a NIMBY, don't take my word for it, please seriously consider and take the word of a fireman, who is also a nurse, and who gave this presentation on Toxicology of the Lithium Ion Battery Fire to the Massachusetts Department of Fire Services:

And consider this excerpt from PPE101 on Lithium-ion battery fires: Understanding PPE contamination hazards:

"What are the hazards of Li-ion battery fire contaminants?"

Given the wide range of potential chemicals, there is an equally wide span of chemical hazards in terms of their toxicity, reactivity and flammability – hazards that can pose both short- and long-term effects. Some of these chemicals are well characterized in terms of exposure hazards that can include acceptable inhalation concentration levels, and in some cases, threshold levels for skin contact, but many are not. In examining some potentially relevant chemicals, some idea of specific hazards can be inferred. *For example, hydrogen fluoride, which is a uniquely dangerous, strong inorganic acid has been found in smoke for Li-ion battery fires at levels approaching 600 ppm. As a frame of reference, the immediately dangerous to life and health (IDLH) concentration for hydrogen fluoride is only 30 ppm.* Furthermore, cobalt is a dangerous heavy metal that is most likely to show up in a form combined with other atoms as an inorganic chemical. Fumes of these chemicals are considered dangerous at relatively low levels in air (NIOSH Recommended Exposure Limit of 0.05 milligram per cubic meter over an 8-hour exposure [4]). What is of greatest interest for this discussion is understanding which contaminants remain on PPE and the expected residual concentrations following the fire event."

If you really believe the consultant's conclusion that it is safe to put lithium battery storage facilities within 20-50 feet of property lines, then I suggest you insist that they build the facility next to your own property line. Until you are confident enough to do that, this citizen of San Diego County demands that you not allow them anywhere near me or my property or my business located in the unincorporated area of San Diego County.

Hello, State reps and Councilmembers,

I am sending this to you because you may, one day, be called upon to approve a battery energy storage facility (BESS) in your community.

I saw an article on MSN that 10 BESS facilities were being proposed or built in wildfire-prone areas like the ones in Escondido, Valley Center, and Otay Mesa, and a few others, that caught fire. In fact, the SDGE facility in Escondido caught fire despite smoke and heat detectors. Technology by itself won't save us. They should have thought of these things first, but the small risks they advertise are rapidly becoming huge risks.

You know the risks and the community best. Please don't give in to the legal or other manipulation.

And by the way, since I live in one of the 10 areas, it's now personal.

My latest issue with lithium-ion batteries is the danger to all of us with

our normal ways of life:

I wrote a few months ago: “The weather has been noticeably cooler for a few days. You would think that this would help the wildfire control. Yet this morning, the 14th, the three big fires near LA and OC, are still raging virtually uncontained: the Bridge fire at 53K acres, 3% containment; the Airport fire at 23K acres, 9% containment; the Line fire at 38K acres, 25% containment. I think the huge Park fire, which we know was started by an EV, was still burning too.

Temperatures for 9/11 in San Dimas (Bridge fire) got down to the upper 50's; San Bernardino (Line fire) and Rancho Santa Margarita (Airport fire) got down to the 60's.

These fires should be on the way out. It is time, maybe past time, to study whether EV's and battery storage facilities (BESS) are contributing to the fires' staying power, especially with lithium's ability to spontaneously combust multiple times.

AND THESE FIRES ARE STILL GOING! Depleting our water, costing money, using firefighter resources and lives.

Also, the EV truck fire on Aug. 19 in Placer County took 50K gallons of water to put out – about 4 times what a family of 4 uses each month. So in a water-poor area, flammable EV's and battery storage (BESS) do not make sense.

Pretty much all batteries are flammable to some degree as is gasoline or hydrogen or even donkey crap if handled wrong. What makes lithium-

ion batteries so dangerous is their ability to combust **spontaneously** and at **relatively low temperature 248 degrees F** (unlike gasoline at 495 degrees F) and the difficulty in putting out these fires.

Another thing that really alarms me is that the BESS companies seem to care about economics more than safety. I saw a KGTV 10 news interview on 11/24/2024 where Jason Anderson, the President of Clean Tech San Diego (a non-profit helping to 'advance' BESS tech) says that despite all the BESS fires at 'older tech' facilities, there are no plans to upgrade or replace them – it would be economically unfeasible (nothing about safety.)

I do not see why these facilities cannot be placed in non-wildfire prone areas like Borrego Springs, Ranchita (I believe) or Ocotillo Wells, or zones like near the Salton Sea, the nearby desert areas (maybe even crossing County lines.)

Another reason to reject BESS placement outside of the coastal zone is that roads in the back-country are not developed enough to handle mass evacuations. Many areas have tiny roads or just one access road which can easily be blocked and trap people and animals. Smaller communities also tend to lack shelter-in-place facilities.

In addition, the insurance cost of homeowners near a BESS facility stands to be canceled or increased in that area, which is fairly discriminatory, especially if you have livestock or agribusiness. Are we all going to have to import our food at a higher price?

Thanks to Jim Desmond at the Board of Supervisors for recognizing the need for BESS safety standards. Hope the measure gets re-introduced

ASAP, so we can control these fires BEFORE they happen and not waste resources on controlling them after.

Here's what I wrote about BESS earlier:

BESS in a wildfire zone is the silliest idea I've heard of for a while. Here are some of my thoughts on this:

Lithium – used in EV batteries – unstable metal – causes spontaneous fires, repeat, spontaneous, you can't put out, toxic fumes, mass evacuations, oh, and the fire just reignited draining fire department resources. And the response from the Big-BESS-Biz: 'We got better technology now.' Isn't that what they said about the Titanic?

I would recommend an enhancement or judicial recommendation for those who start BESS wildfires, to include those who knowledgeably situate a BESS facility in a high-risk area (including near civilization) with inadequate precautions. This should be an extra year for each death and an extra fine to make up for firefighter time and resources.

The Battery Storage (BESS) fire in Otay Mesa burned for about a week. Firemen were monitoring it even longer instead of being elsewhere, and they evacuated people within a mile.

There are proposals for larger BESS facilities in San Marcos and Poway near a major hospital, school, and residences, within a few hundred yards in San Marcos and 1/2 mile in Poway. Lithium ion batteries put out toxic fumes like phosphorous pentafluoride and are a huge wildfire

hazard and would draw away fire dept resources to monitor fire for weeks.

Whoever approves these things (The Board of Supervisors has approved a lot of them) should designate safe areas for these away from houses, schools, and hospitals and wildfire zones, environmentally sensitive areas or water sources which they would pollute.

I doubt, for instance, that the EPA and all would take it too kindly if the toxics from a BESS fire fell on a national monument after all the years and effort to plan it.

If, as I suspect the moneyed and persuasive BESS guys do get a nearby storage site, the Fire People need to get a supply of "F-500 Encapsulator Agent" to help extinguish BESS lithium fires, which cools the fire and interrupts the chemical reaction involved in the lithium battery combustion.

And for smaller BESS or EV fires, you want a supply of aqueous vermiculite dispersion (AVD) or a foam extinguisher containing powdered graphite or sodium carbonate.

And it might help to put Chickenwire or other mesh over BESS facilities to reduce the danger from floating embers or burning airborne leaves in a wildfire.

Hello,

You know the risks and the community best. Please don't give in to the legal or other manipulation.

A few suggestions:

1. Allow a buffer zone of 1 mile per 75 megawatts away from hospitals, houses, schools, and jails.
2. Consider mandating BESS facilities in non-wildfire prone areas like Borrego Springs, Ocotillo Wells, or zones like near the Salton Sea, the nearby desert areas (maybe even crossing County lines.) In the alternative, have a policy of approving BESS facilities only in these areas.
3. Ensure that there are at least 2 paved and at least 15-foot-wide evacuation routes within 100 yards of a BESS facility and leading to a major highway, or develop them.

4. Ensure that shelter-in-place facilities every 10 miles.

5. Wind pattern (Plume) modeling must be conducted for worst-case scenarios based upon historical data (e.g. Cedar Fire wind conditions) An online presentation on 11/14/24 stated that plume modeling would be based upon 'typical' wind patterns. Backcountry wind models vary widely depending on the season.

6. Require applicants to secure a \$10 million liability bond as a mitigation measure. Communities should not have to worry about being made whole in the event of a very foreseeable disaster

7. Require a one-year pre-notice period to affected communities within at least a 2 mile radius from the project from all potential applicants. These projects should not come as a surprise to affected communities.

8. Mandate the installation and Frequent (daily?) tests of smoke detectors or heat sensors.

9. Community Liaison and someone from the community not in the BESS or energy biz on the Board of the company managing the system.

10. Medical person on the Board of the company managing the system.

11. Document all safety incidents and make those records publicly available. Also monitor and publish noise level readings from these often very-loud projects. Transparency is key to maintaining public trust and accountability.

12. Have adequate fire suppression agents onsite, like "F-500 Encapsulator Agent," aqueous vermiculite dispersion (AVD,) or a foam extinguisher containing powdered graphite or sodium carbonate.

13. Chickenwire or other mesh over BESS facilities to reduce the danger from floating embers.

14. Implement an enhancement for those who start BESS wildfires, to include those who knowledgeably situate a BESS facility in a high-risk area (including near civilization) with inadequate precautions. Suggest an extra year for each death and an extra fine to make up for firefighter time and resources.

Exactly how Bhattacharya and Kennedy would reform the agency is unclear. Among the ideas that some Republicans have proposed is implementing term limits for directors of individual institutes, so that no single person overseeing huge amounts of medical funding becomes too powerful. House Republicans have also proposed consolidating some of NIH’s many institutes.

Bhattacharya gained prominence during the Covid pandemic with the controversial Great Barrington Declaration, which argued for an end to lockdowns before vaccines were available. Keeping shutdowns in place until a vaccine was available “will cause irreparable damage, with the underprivileged disproportionately harmed,” the declaration said.

Their ideas were vigorously attacked by the public health establishment, including former National Institute of Allergy and Infectious Diseases head Anthony Fauci, who called the declaration’s concepts “very dangerous.” But since then, the downsides of long pandemic-related interruptions have become more apparent, including in mental health and children falling behind as schools leaned on remote learning.

Bhattacharya said in a post on X that he was honored and humbled by the appointment. He said he aims to “reform American scientific institutions so that they are worthy of trust again.”

Deadline looms for family struggling to move tiny home out of Vista RV park

VISTA, Calif. (KGTV) -- A Vista family has a big cloud hanging over their head this Thanksgiving -- they need to move their entire house by Dec. 1.

ABC 10News reported earlier this month on how the Green Oak Ranch RV Park is changing hands and forcing its residents to leave.

On Thanksgiving Eve, LaRen Reed's girls skated around in their current neighborhood. In the meantime, LaRen was thinking about Thanksgiving prep.

"This year, I'm doing all bacon," said LaRen. "Bacon-wrapped jalapeño poppers, bacon-wrapped hot dogs, bacon chili."

But what's hovering in the background is the need to move their tiny home by Sunday, Dec. 1.

"We can't just pull a truck up to the house and pull it out," said LaRen. "We have found some places locally, but the space is 30 feet and our place is 40 or there's no hook-ups. So, it's been really difficult finding a place."

Green Oak Ranch is vacating the site, which is being taken over by Solutions for Change, a group that services the homeless.

However, Solutions for Change said it will not operate outside of the law or at the expense of their core programs. For instance, ABC 10News also reported that people living in the RV park were not living there legally.

ABC 10News previously spoke to residents, including Carrie Gibbs. She said at the time, "I feel like we're all just all priced out. We're not low enough to be good enough for solutions. We're not high enough to find anything on our own. And anything in between."

For LaRen, she's frustrated and wishes things could have been done differently.

"I don't wish it upon anybody," said LaRen. "It's a really difficult time for the holidays. We don't even know what Christmas is going to look like for our family. My husband had a stroke a couple years ago. I'm dealing with some medical issues myself. And then the move on top of it, it's just overwhelming."

LaRen said San Diego Rescue Mission reached out to them to help with relocation services, but said her family needs more time.

Dear Chair Vargas,

I am writing to you on behalf of the Spring Valley Community Planning Group to support the adoption of a **Smoke-Free Outdoor Public Places** ordinance for the Unincorporated Area of San Diego County. This ordinance would protect our communities by creating cleaner air, free from the chemicals found in secondhand tobacco and cannabis smoke. It would also preserve the environment in our Unincorporated Area by reducing toxic tobacco product waste which can be absorbed by plants and soil, kill fish and pollinating bees, and contaminate drinking water.

Tobacco use is often responsible for starting destructive wildfires. As of August 29, 2024, a total of 5,435 wildfires had burned a cumulative 834,766 acres in California, and an average of 44 wildfires a year are started from tobacco use. The state has experienced \$18.7 billion in property damage from wildfires over the past five years. Residents are struggling to pay increased homeowners' insurance or are unable to insure their homes because of wildfire risks in our County.

The Spring Valley Community Planning Group serves the community by advising the County of San Diego on planning and land use matters. At the November 12th meeting of the SVCPG; the group voted unanimously to support this ordinance, which would enhance the health and safety of our community, protect our natural resources, and contribute to a healthier environment for all. We would like to thank you for your efforts in protecting public health and keeping the Unincorporated Area safe, and we urge the San Diego County Board of Supervisors to make all outdoor areas in our Unincorporated Areas smoke-free.

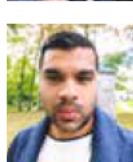

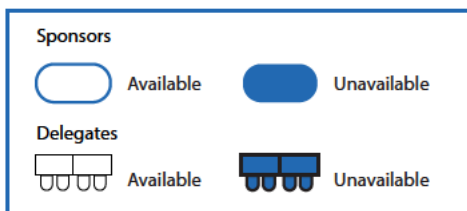

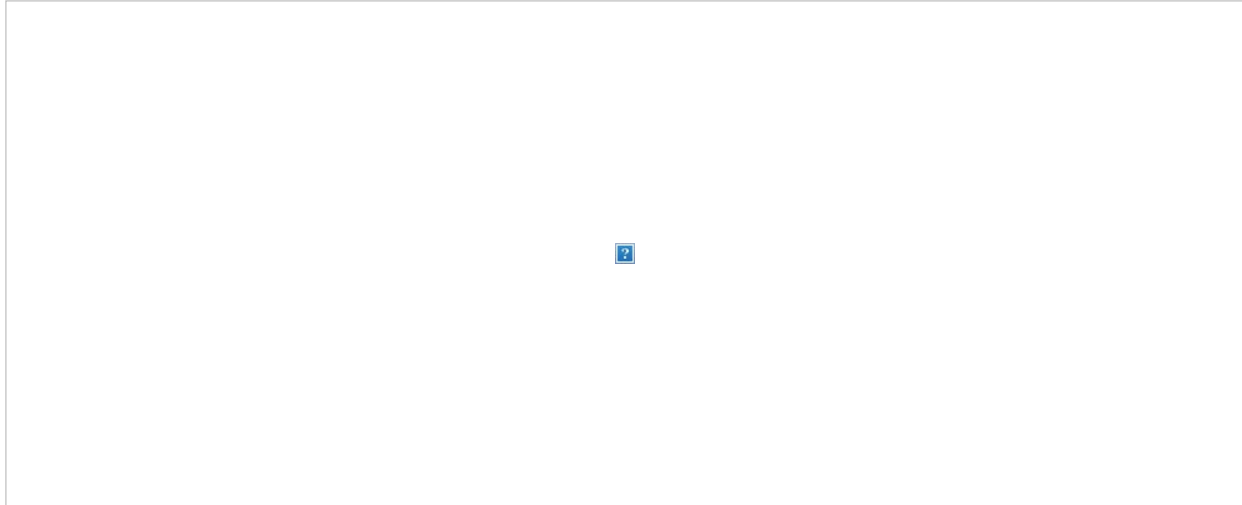

Hello. I emailed Sacramento County Board of Supervisors ([source 1](#)) on July 23, 2024, and informed California’s fifty-seven other Board of Supervisors ([source 2](#)) six days later, that “[COVID-19] *Vaccines Are Killing People...*,” ([source 3](#)).

The purpose of this document is to update what has happened since then, and report COVID-19 “*vaccines are killing people...*” at an alarming rate.

According to [VAERSAware.com](#) lead investigator **Julie Threet** —who is COVID-19 vaccine injured ([source 4](#)) —as of November 29, 2024, there were 442 adverse events filed for Californians vaccinated on or after August 1, 2024.

Here's the time stamp: Dr. **Tribble** (1:54:34); Dr. **Parks** (2:05:02); Dr. **Cole** (2:10:35); Dr. **McCullough** (2:27:23); Dr. **Thorp** (2:32:27); Dr. **Wiseman** (2:39:29) and Dr. **Moon** (2:57:00).

These seven SME's are not alone. Over 17,000 physicians and scientists have called for COVID shots to be pulled off the market ([source 13](#)), according to Americans for Health Freedom (AHF). Retiring Sacramento County Board of Supervisor **Sue Frost** is the only California elected official on record who called for COVID shots to be discontinued, according AHF, founded by Dr. **Mary Talley Bowden**.
