





San Diego's HUD-VASH program has housed over 1,000 homeless veterans since 2008, reaching 2,000 active vouchers by 2024. With 1,285 vouchers allocated, it offers case management and mental health services, reducing veteran homelessness by 52% nationally since 2010. Partnerships with SDHC and nonprofits, plus \$29M in 2023 funding, bolster success. A 2024 HUD policy change improved eligibility by excluding disability benefits from income calculations.

However, San Diego's tight rental market is a hindrance, and landlord reluctance limits voucher use. Limited funding leaves some veterans underserved despite high demand. While effective, the program struggles to scale amid resource constraints, especially due to California putting illegal immigrants (i.e. potential votes) first. Pretty sad actually. You all need to work together, along with vets, to solve this (challenging) problem.
