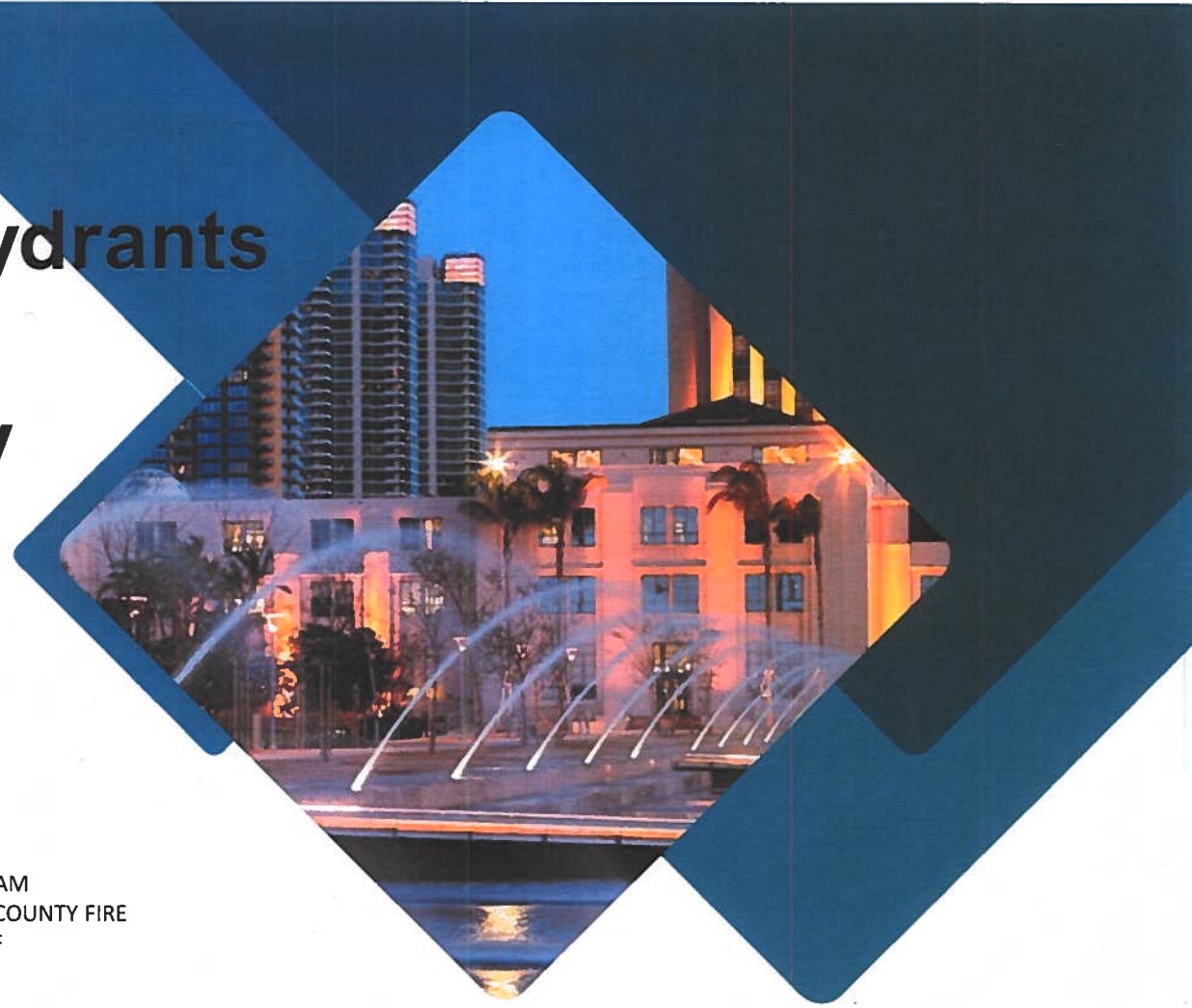

Specifications

HELI-HYDRANT

- Stationary
- 5,000 Gallons
- Automated Refill (Municipal Water Source required)
- \$250,000

HELOPOD

- Portable
- 5,000 Gallons
- Manual Refill via Water Tender or Municipal Water Source
- \$50,000





Existing Locations

- In 2021, the region's first Heli-Hydrant site was established in North County
- HeloPods, currently located at:
 - CAL FIRE Station #50, Julian
 - CAL FIRE San Diego Unit, El Cajon

Proposed Locations

Scheduled to be fully operational in Fall 2022

Heli-Hydrant

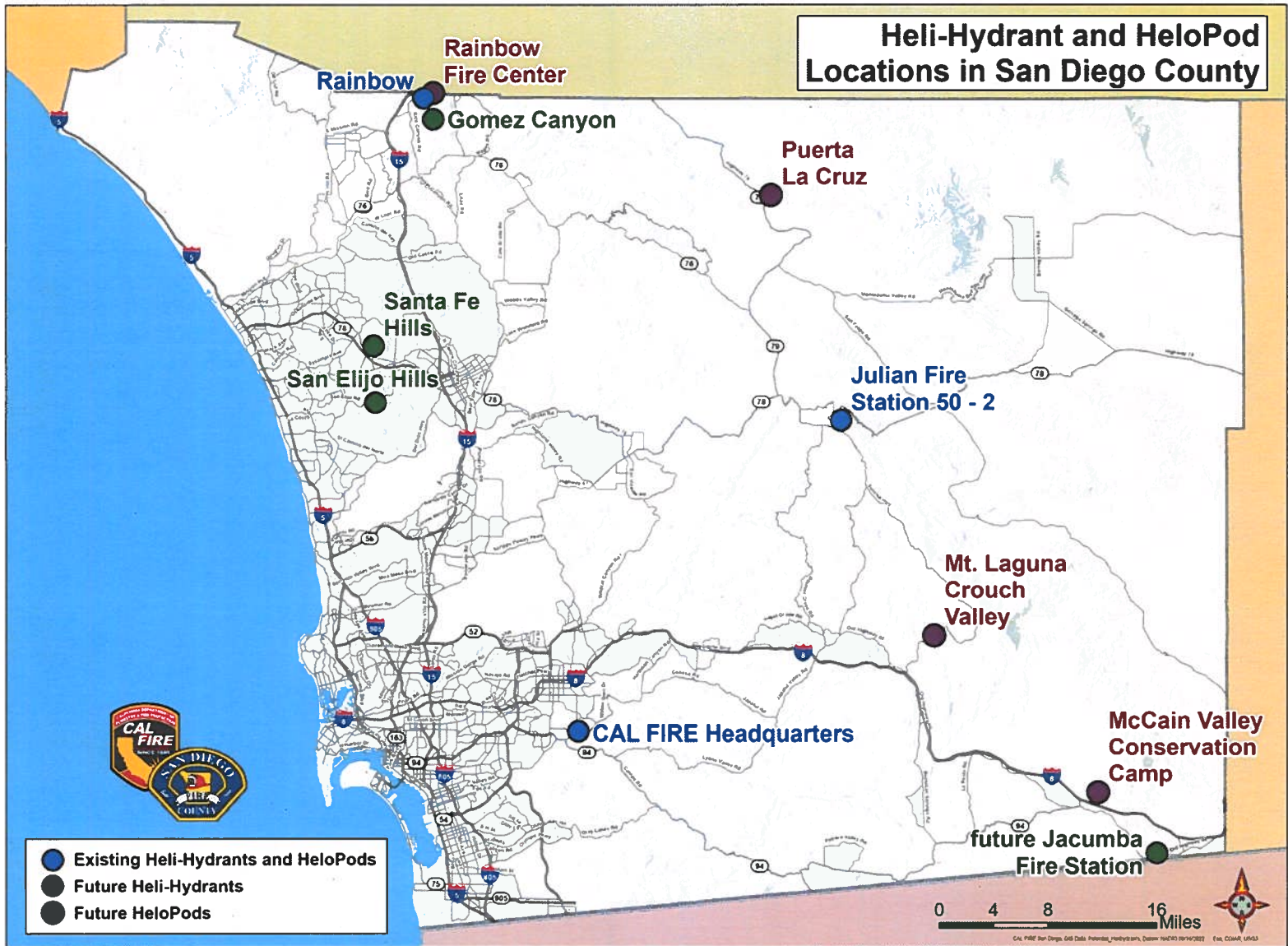
- Santa Fe Hills, San Marcos
 - Site completed through a partnership between County Fire, the San Marcos Fire Department and Vallecitos Water District

HeloPods

- Rainbow Fire Center, Fallbrook
- McCain Valley Fire Camp #21, Boulevard
 - Helopods purchased by CAL FIRE

Key Recommendations

- Authorize an agreement between County Fire, San Marcos Fire and the Vallecitos Water District for the shared use of the Santa Fe Hills Heli-Hydrant site
- Approve the future lease of property and authorize the Department of General Services to negotiate lease(s) and return to the Board for approval, if necessary
- Authorize the single source procurement of Heli-Hydrant and HeloPod equipment and services

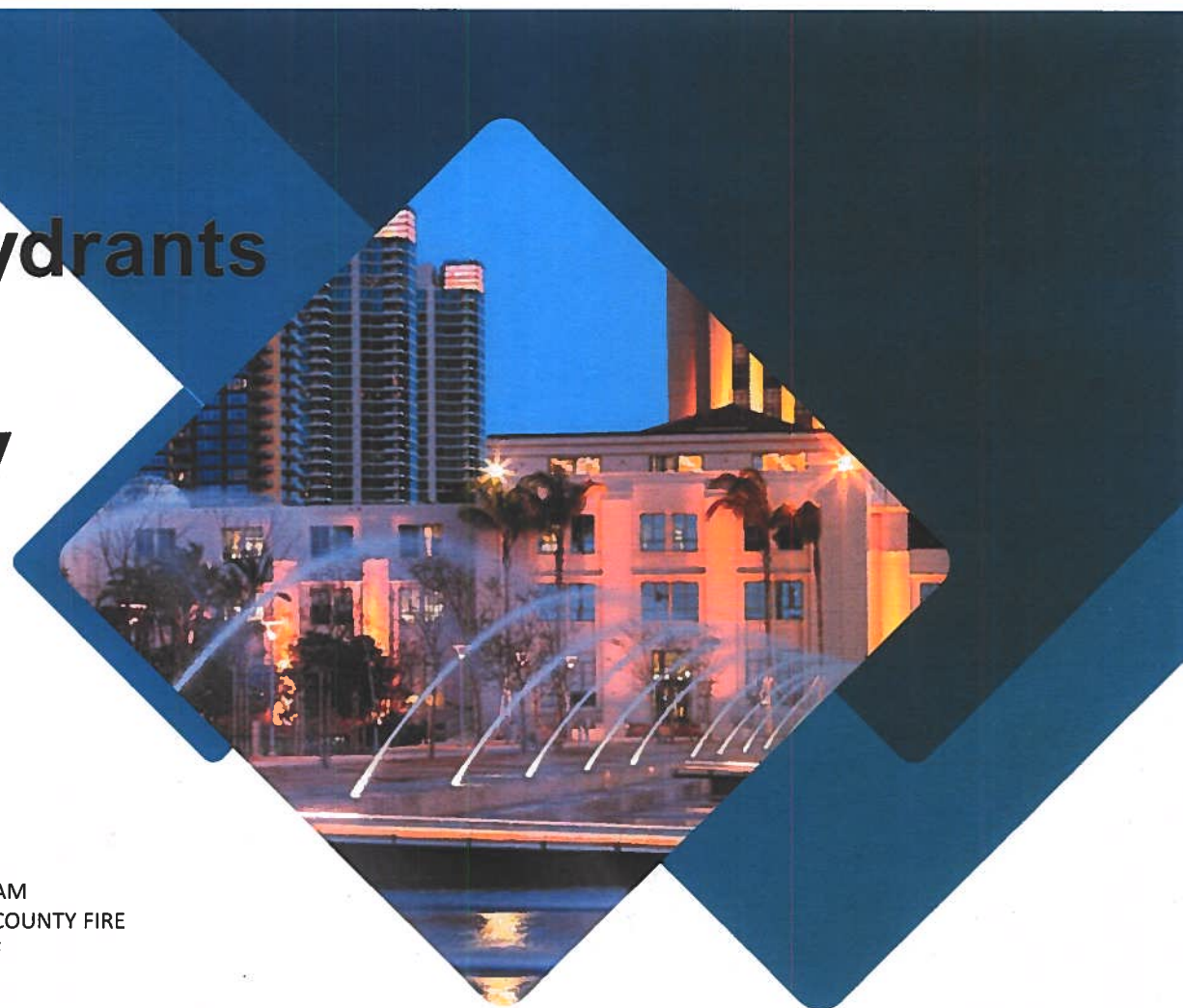
