A waiver of Board Policy B-29 is requested because the funding does not offset all costs. Unrecovered costs are estimated at \$33,104 for Fiscal Year 2022-23 and \$33,104 for Fiscal Year 2023-24. The funding source for these costs will be Health Realignment. The public benefit for providing these services far outweighs these costs, as the California Department of Public Health, Office of AIDS Integrated HIV Surveillance and Prevention funding for Health Departments funding fills an important gap in the local HIV service delivery system by ensuring support for existing HIV prevention contracts, which provide HIV testing, outreach, health education, and linkage to anti-retroviral therapy, pre-exposure prophylaxis, potential exposure prophylaxis, and other resources. The County of San Diego County (County) Health and Human Services Agency certifies that these services will be worthy of County support if outside funding were not available.
