





The State of California fire code requires secondary access when there is a dead end road longer than 800 ft. The County designated this a risky place to build due to fire risk and lack of evacuation routes.

Mark Arsenault bought and wants to re-zone the property. The fire district, which routinely turns down even minor lot splits, when secondary access is not provided, has ignored its own rules. An \$850,000 contribution has clouded its good judgement.

The community itself is mostly rural, known for its wildlife, open space reserves, and natural beauty. We must protect areas like this from developments that prioritize profit over public safety and ecological integrity. The entire neighborhood has been deemed a Very High Fire Severity Zone by Cal-Fire Maps. Does it really seem safe to place 1000 residents in a Very High Fire Severity Zone with only one exit, especially when Fire Code says it isn't? In a Santa Ana wind driven fire, people are going to end up trapped on the road, or they will die in their homes because they think "fire hardened" means "fire safe." In the Coco's fire I evacuated past 6' high flames. I was able to evacuate because only about 75 of us lived on Country Club, not the 1000 or so HGVS would bring. At a Community Meeting on 9/17/25, RSFFPD Chief McQuead stated that HGVS would not be approved by the Fire Department now because there was no secondary exit. Why is this development being held to 2018 standards and not current standards?
