Dear Board of Supervisors:

The City of El Cajon supports the piloting of a shallow rental subsidy program for older adults who are at-risk for homelessness in the County, and especially in El Cajon. The City, in consultation with homeless services providers in El Cajon, has noted with concern the growing numbers of older adults who are homeless in the City, many of which are homeless for the first time. With the cost of housing continuing to rise, older adults on fixed incomes and with no other economic safety net are facing an inability to pay rent increases, let alone pay for necessary expenses such as food, transportation, prescriptions and other medical expenses. Many older adults are losing their housing, and an increasing number are seeking services at local shelters or are encountered in areas not fit for habitation.

For these reasons, the City of El Cajon supports the design and implementation of a County-wide shallow rental subsidy program for older adults. However, there is concern about how this program would be funded into the future. This type of program is not suitable for implementation on a short-term, temporary basis, since many older adults cannot be expected to increase their incomes through new employment. The City strongly recommends that the County, if it moves forward with implementing the program, identify and commit dedicated funding for a longer-term solution.
