AMENDS APPENDIX ONE	SECTION 1 Amends Appendix One of the Compensation Ordinance	This section is amended by establishing compensation which provides wage increases for DS and SM bargaining units: Across the board changes: Fiscal Year 2026-2027: 3% wage increase effective June 26, 2026 Fiscal Year 2027-2028: 3% wage increase effective June 25, 2027 Fiscal Year 2028-2029: 3% wage increase effective June 23, 2028 Effective on June 26, 2026, and June 25, 2027, a 5% top step will be added to the following classifications: Deputy Sheriff (005746), Sheriff's Captain (005775), Sheriff's Commander (005778), Sheriff's Lieutenant (005780), Sheriff's Sergeant (005790). Effective on June 23, 2028, a 5% top step will be added to the following classifications: Dep Sheriff – Detentions/Court Services (005757), Sheriff's Detentions Lieutenant (005767), Sheriff's Sergeant Detentions (005781), and Sheriff's Detentions Captain (005783).
AMENDS APPENDIX ONE	SECTION 2 Amends Appendix One of the Compensation Ordinance	This action amends the salary grade for Chief Financial Officer in the Unclassified Service.
AMENDS SECTION 1.7.12	SECTION 3 Amends Section 1.7.12	This action amends In-Service Sheriff's Training premium by increasing the premium from \$45.00 to \$100.00 biweekly.
ADDS SECTION 1.7.45	SECTION 4 Adds Section 1.7.45	This action amends compensation for bargaining unit DS by incorporating the 2.5% Major Crimes premium into the base wage.
ADDS SECTION 1.7.46	SECTION 5 Adds Section 1.7.46	This action amends compensation for bargaining unit DS by incorporating the 5% K9 premium into the base wage.
AMENDS SECTION 1.9.2	SECTION 6 Amends Section 1.9.2	This action increases the Bilingual premium from \$75.00 to \$100.00 biweekly for bargaining unit DS.
