





There are too many objectionable things in this ordinance. It could lead to too much fraud, waste, or abuse. With an unresolved reserve deficit and budgetary funding shortfalls or even claw-backs expected, it is not a good time to spend an estimated \$1.3 million on expanding Board policy A-53.

The 25% increase the Director of Purchasing & Contracting can make without your permission under Attachment B, San Diego County Code section 401 (c) is too much. There needs to be a dollar limit as well as the percentage.

And there are way too many exceptions from competitive procurement (utility, educational, standard off-the-shelf software, operating and maintenance for software, medical equipment, news and subscriptions, goods and services just for the CAO and Board (sounds fraudulent)) in Policy A-87, attachment G, procedure 2 A on page 5.
