

My name is Alec Cotugno and I have lived in Julian for 5 years. I live in the neighborhood known as Kentwood 1, which is directly outside of the main town of Julian. I am a licensed Remodeling General Contractor, as well as a co-owner of Studio Ocho Cuartos an Interior Design, Furniture and Lighting studio based here in Julian. I work here in Julian and the surrounding areas, as well as in San Diego and Imperial County. Our businesses together have generated projects whose budgets collectively sum in the hundreds of thousands of dollars. We have consistently utilized local technicians and craftspeople and we purchase much of what we use on our projects from local retailers.

I love living in Julian. I love the local culture and the natural beauty of the clouds and mountains and wildlife. My daughter attends preschool at Spencer Valley School in Wynola. I frequently attend local events and activities, in fact I have attended multiple ARB meetings in the past as a visitor just to understand the ARB and its methods and goals. I also love many of the local businesses in Julian and I want to do my part to create a community that is as small business friendly as possible.

I specialize in natural and local building materials, including earthen building techniques like adobe, rammed earth, and earthen plaster made from Julian soil. I also specialize in lime plaster and natural paint finishes that would have been utilized in Julian between 1870 and 1913. My specific knowledge and experience with these materials and practices would be an invaluable asset to the Architural Review Board.

While I specialize in these building techniques, I'm also a 21st century contractor and business person. I understand intimately the costs associated with construction and design. I also understand how to put together design proposals and estimates for construction. I also work with suppliers in San Diego and understand what is locally available. I know how to read building plans and blueprints, and I understand the issues and problems that are common in older homes and buildings.

Julian has many thriving businesses, all of which are small businesses, or started as small businesses. I believe we all need to do more to encourage our small business community. The Architectural Review Board is an ally to the small businesses in Julian because the magic of Julian is in its historical aesthetic and cultural charm. The more we preserve the magic of Julian, the better for small businesses.
