





We should not be Providing loans with a minimum 55-year affordability period, at or below market rate [Sec. 232.5 (c)] except to a few people.i This gets us in the poorhouse and assumes that that people loaned to will not do better off in 55 years which is unlikely.

Salaries of County employees should not be paid from a trust fund (g). That depletes the trust fund unnecessarily. The trust should be used for its stated purpose, not for salaries.
