You're invited to our Press Conference regarding the following:

The boards planned actions on Tuesday will adopt a resolution and Board Policy L-2 to affirm the County shall not provide assistance or cooperation to ICE in its civil immigration enforcement efforts, including by giving ICE agents access to individuals or allowing them to use County facilities for investigative interviews or other purposes, expending County time or resources responding to ICE inquiries or communicating with ICE regarding individuals' incarceration status or release dates, or otherwise participating in any civil immigration enforcement activities.

The boards planned actions will be going against the incoming administration's plans to deport, end sanctuary status and hold those involved in harboring illegal aliens accountable using federal statute 8 U.S.C. § 1324, etc. There have already been consequences due to these policies, a 5yr old little girl was raped and her offender a 22 year old illegal alien is being protected under these proposed actions and current policies.

My daughter and her roommates experienced this first hand ..

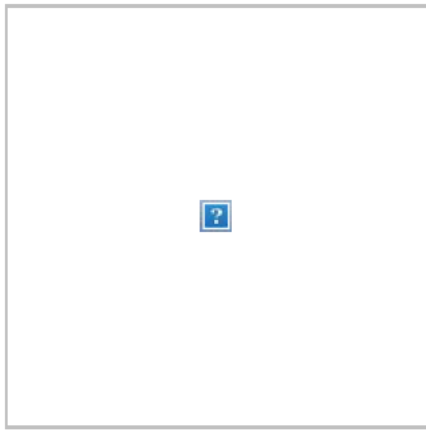

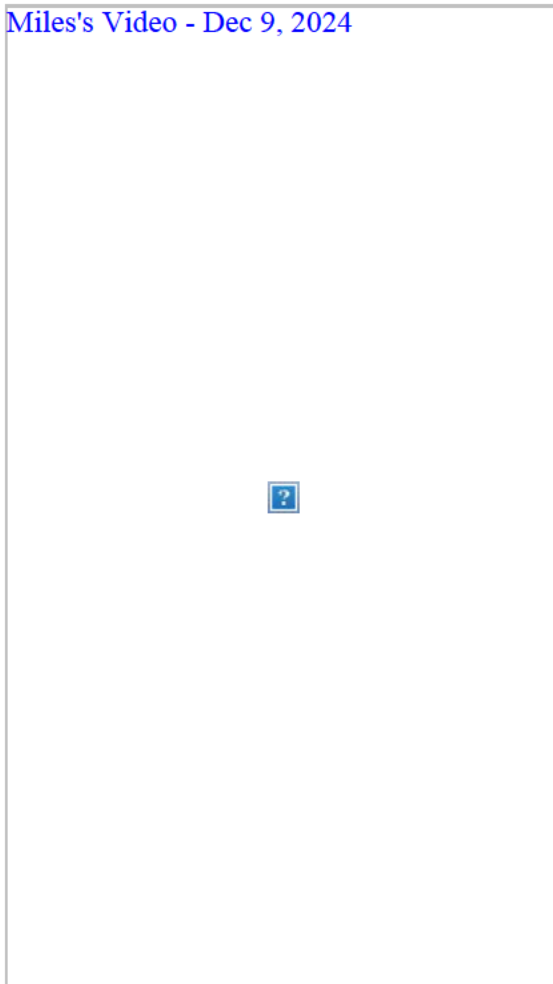

Dean --

I want to take a moment to address an issue that many of you have expressed concerns about ahead of tomorrow's Board of Supervisors meeting: the proposal to restrict our local law enforcement from cooperating with Immigration and Customs Enforcement (ICE).

Let me be clear: I am completely against our current sanctuary state policy. However, as it stands, there is at least a carve-out that allows local law enforcement to notify ICE when individuals who are in the country illegally, and have committed severe crimes such as rape, stalking, child abuse, gang violence, or burglary, are about to be released from jail. This critical provision enables ICE to intervene and ensure these dangerous individuals are deported, protecting our communities from further harm.

The proposal we will consider tomorrow seeks to eliminate even this carve-out, stripping local law enforcement of their ability to communicate with ICE about criminals who pose a serious threat to public safety. This would allow individuals who have committed heinous crimes to remain in our communities, increasing the risk to innocent people.

I am adamantly opposed to this proposal. People who are here illegally and commit serious crimes should be deported, and our law enforcement must have the tools they need to protect the safety of our residents.

This isn't just a policy debate; it's about real lives. A few months ago, I sat beside Patty Morin, a grieving mother whose daughter was raped and murdered by someone shielded by sanctuary policies. Her testimony was devastating, and her loss was preventable. We cannot let tragedies like this happen in San Diego County.

Sanctuary policies like these have already led to heartbreaking consequences. They compromise public safety by shielding dangerous individuals from accountability and forbidding local law enforcement from cooperating with federal authorities.

I invite you to join us tomorrow, whether in person or by watching the meeting online, to stand against this dangerous proposal. Together, we can ensure that San Diego County remains a safe place for its residents.

Board meetings are held in the Board Chamber (Room 310) of the County Administration Center, 1600 Pacific Highway, San Diego, CA 92101.

1. You must fill out a Request to Speak form if you want to speak at the meeting. Forms are available outside Room 310 and in the Chamber.
2. Write in the information and give it to the Deputy Clerk. You will need a form for each item you want to speak on.

3. You need to turn in the form before public comment on that item begins. You can only turn in a form for yourself to speak. You cannot turn in a form for someone else.
4. The Clerk of the Board will call your name when it is your turn to speak.
5. You will have two minutes. You cannot give your time to someone else.

**Call in comments during a meeting.**

1. [Fill out a tele-comments form.](#) You need to submit the form before public comment on that item begins. After you submit the form, you'll get instructions on how to call into the meeting.
2. [Watch or listen to the meeting.](#)

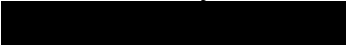
