I write on behalf of Planned Parenthood Action Fund of the Pacific Southwest to express our strong support for the resolution in support of Proposition 35. This initiative is vital for ensuring that all residents have access to health care services.

Prop 35 provides dedicated funding to improve the health care system for all patients in California, including 15 million Medi-Cal patients. Prop 35 will address our most urgent health care priorities by securing dedicated, ongoing funding – without raising taxes on individuals – to protect and expand access to care, including funding for community health care providers like Planned Parenthood, who predominantly serve patients who rely on Medi-Cal for access to vital care.

Planned Parenthood Action Fund of the Pacific Southwest is proud to be a part of a coalition composed of doctors, health care workers, community health centers, and emergency responders staunchly in support of the Yes on 35 Campaign.
