B-29 Fees, Grants, Revenue Contracts - Department Responsibility for Cost Recovery

BOARD POLICY STATEMENTS:

California Government Code Section 51350 states counties cannot charge cities for services that are made available to all portions of the County. Examples of these "regional services" include the services of the Crime Lab, Aerial Support to Regional Law Enforcement Agencies (ASTREA), Special Enforcement Detail, Bomb/Arson, Property and Evidence, and Search & Rescue. Government Code Section 51350 also precludes the charging of general overhead costs. General overhead costs are those which would exist regardless of the existence of the contract, such as the Office of the Sheriff, and select portions of overhead costs from support departments including the cost of the Board of Supervisors and the Chief Administrative Office. Due to the provisions of Government Code 51350, it is requested that the Board waive Board Policy B-29, related to full cost recovery for fees, grants, and revenue contracts.
