





Dear Supervisors,

Thank you for the update regarding the planned County Board letter on November 18. I'm writing to share a different perspective on the federal Medicaid policy. The updated rules are intended to ensure taxpayer funds are used in accordance with long-standing federal requirements separating Medicaid reimbursements from abortion-related services. The policy does not remove healthcare access; patients may continue receiving care from any qualified provider that meets Medicaid standards. Many providers in San Diego already offer comprehensive services—cancer screenings, prenatal care, contraception, and STI treatment—while remaining fully eligible for reimbursement.

While I respect the Attorney General's decision to challenge the policy, I do not believe the County should issue a letter supporting the lawsuit. A balanced review is warranted, and the federal government's interest in program integrity and fiscal accountability should be acknowledged.
