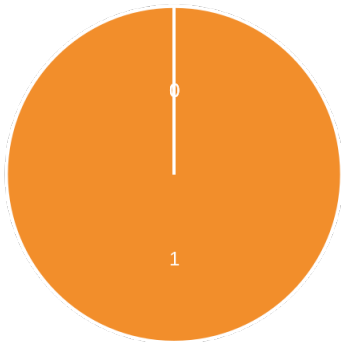

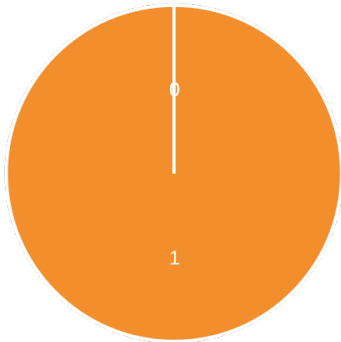

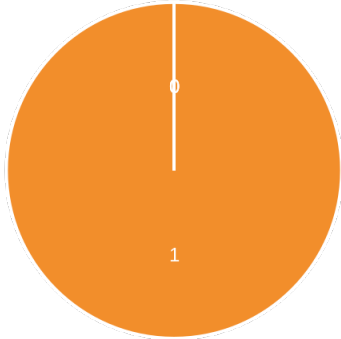
### Overall Sentiment
