NOTICE IS HEREBY GIVEN that on February 25, 2025, a public hearing as required by California Government Code Section 99.02, which establishes the process for transferring property tax revenue and adjustment of the property tax allocation between two local government agencies that have overlapping tax rate areas when jurisdictional boundaries are not changing, will be held with respect to a proposed plan of property tax reallocation to 6% for the Deer Springs Fire Protection District (DSFPD) and Valley Center Fire Protection District (VCFPD).

The Board is holding a public hearing is to consider the effect of the proposed transfer on fees, charges, assessments, taxes, or other revenues. The Board is also being asked to adopt a resolution that satisfy the conditions in Section 99.02(c) and (f), which include the conditions that the transferring agency determines that revenues are available for this purpose, that the transfer will not result in any increase in the ratio between the amount of revenues of the transferring agency that are generated by regulatory licenses, use charges, user fees, or assessments and the amount of revenues of the transferring agency used to finance services provided by the transferring agency, the transfer will not impair the ability of the transferring agency to provide existing services, and the transfer will not result in a reduction of property tax revenues to school districts.

The public hearing will commence at 9:00 a.m., local time, or as soon thereafter as the matter can be heard at the County Administration Center, 1600 Pacific Highway, Room 310, San Diego, CA 92101. Those wishing to comment on the proposed nature and location of the facilities and the financing of the facilities with the proceeds of the Bonds may either appear in person at the time and place indicated above or submit written comments, which must be received prior to the Public Hearing by the County of San Diego, Attention: Clerk of the Board of Supervisors, 1600 Pacific Highway, Room 402, San Diego, California 92101 or via eComment through the County's website at www.sandiegocounty.gov/ecomment.
