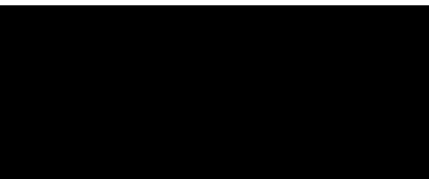

I am requesting access to records in possession or control of the **San Diego County Sheriffs Department and/or County of San Diego** for the purposes of inspection and copying pursuant to the California Public Records Act, California Government Code § 7920.000 et seq. ("CPRA"), and Article I, § 3(b) of the California Constitution. The specific records I seek to inspect and copy are listed below. As used herein, "Record" includes "Public Records" and "Writings" as those terms are defined at Government Code § 7920.530 & 7920.545.

I request access to inspect/copies of all internal records and internal/external communications, evidence, property seized from the address of [REDACTED] 92007, and all documents, emails/all internal communications revolving, and relating to, about and around Criminal Case file CN417303 from before, during and after arrest 9/17/2020 to present date of when this request is submitted and to include response to:

1. January 31, 2024 **COMPLAINT** submittal tot he Department via email regarding misconduct to Sheriff Kelly Martinez. No answer provided as represented would be provided.
2. February 22, 2024, **COMPLAINT** to Sheriff Kelly Martinez **RESUBMITTAL** via email of January 31, 2024 **COMPLAINT** regarding misconduct to Sheriff Kelly Martinez. No answer provided as represented would be.
3. Further, I wish to know a description of property and what happened to the property seized from my home relating to Criminal Case file CN417303 and return of this property, it's current location and custodian.
4. I wish to know the evidence, internal and external communications used to support proof Molotov cocktails existed in my vehicle at the time of my arrest on or about 9/17/18 2020, the tests proving this existed with photographs used to determine I had alcohol bottles in my vehicle and that they were Molotov cocktails.
5. A copy of the receipt taken from my vehicle or any document that could relate evidencing the purchase or potential purchase or document that might relate to the purchase of a gun/firearm or any document relating to guns/firearms claimed to have been found in my vehicle.
6. Response to my letter for appointment contained in the body of communications January 31, 2024 AND February 22, 2024 with Kelly Martinez and what and how the Department plans to address the issues. Any further reference of detail is contained in these letters not responded to over 3 months later.

If you contend that any portion of the records requested is exempt from disclosure by express provisions of law, Government Code § 7922.525(b) requires segregation and redaction of that material in order that the remainder of the records may be released. If you contend that any express provision of law exists to exempt from disclosure all or a portion of the records I have requested, Government Code § 7922.535 requires that you notify me of the reasons for the determination not later than 10 days from your receipt of this request. Government Code § 7922.540 requires that any response to this request that includes a determination that the request is denied, in whole or in part, must be in writing and include the name and title of the person(s) responsible for the City's response.

Government Code § 7922.500 prohibits the use of the 10-day period, or any provisions of the CPRA or any other law, "to delay access for purposes of inspecting public records."

In responding to this request, please keep in mind that Article 1, § 3(b)(2) of the California Constitution expressly requires you to broadly construe all provisions that further the public's right of access, and to apply any limitations on access as narrowly as possible.

If I can provide any clarification that will help expedite your attention to my request, please contact me at [provide phone or email address], pursuant to Government Code § 7922.600. I ask that you notify me of any duplication costs exceeding \$xx before you duplicate the records so that I may decide which records I want copied.

If you reference my email attempts, you will see from January 2024 I attempted response from Kelly Martinez and the Department.

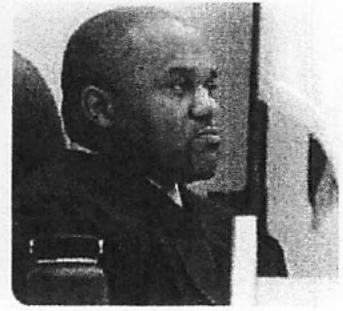
