A-87 - Request for Single Source Procurement of On-Site Narcotics Destruction Services from GAIACA Waste Revitalization.

Item or Service and Term Period: As-Needed On-Site Narcotics Destruction Services

Benefits to the County of San Diego: The Sheriff's Property and Evidence Unit disposes of an estimated 15 tons of various drugs annually. This includes drugs like marijuana, heroin, cocaine, fentanyl, methamphetamine, and prescription medications. Unfortunately, it has been brought to the Sheriff's attention that the last remaining waste-to-energy facility in California will shut down effective December 2024, leaving the Sheriff's Office without a means to destroy narcotics. Therefore, having another option readily available through GAIACA's on-site destruction services would benefit the Sheriff's Office to ensure uninterrupted narcotics destruction services and keep these narcotics from returning back into the community, while keeping critical Sheriff staff within the County.
