

Hello, My name is Corey French, I'm a 36 year old male working at College Copy Center and living in La Mesa.

I'm writing today to let you know how horrible my life has been here the last 18 years I've been living as an adult in San Diego. My aim is to shed some light on problems and also make you guys understand the ridiculousness of some of the things people like me have been having to go through.

Being born and raised here, after 11 years of working a "full time" job in La Mesa and living here in La Mesa, at a store where I'm a manager making \$6/hr over the minimum wage, I am now 12k in debt and can not longer afford renting here pretty much anywhere now in all of San Diego, and so I'm planning on becoming homeless next month.

THAT'S what 11 years of being a loyal worker (9 years of which have been being a manager) in San Diego gets you : homeless.

The rent on my 400 sq. ft., 1-window studio has gone up 50% in 5 years(10% per year) and my wages have gone up a whopping 4%.

I have been literally paycheck to paycheck since I started working at age 16, 20 years ago! This entire time, one flat tire away from the streets. I've never had more than \$500 saved in 20 years. Mentally, I have been living life in "fight or flight" mode since 16. I estimate 95% of the people I know in San Diego are in the same boat, and I know alot of people because I have been skateboarding around this town for 31 years.

Section 8 still has nothing for me and I've been on their list for 9 years. Well, it was actually 12, but they goofed up the paperwork, and reset it at 9 years. Still, every unit is full and has a gigantic list.

According to the Massachusetts institute of technology, the livable wage for California in 2024 was \$27.32/hr. After 10 years of hard and committed work and staying loyal to a company, I have finally earned myself - \$6.32/HR UNDER WHAT IS CONSIDERED "THE LIVABLE WAGE".

In La Mesa, it was stated that "\$33.75/hr" was a living wage in La Mesa. The minimum wage here however, is \$16.50/hr.

THAT IS HALF!!!

HOW IS THIS LEGAL? DO YOU NEED HELP? THIS IS RIDICULOUS!

I should be making so much more money, and it ain't coming from small business owners. My store did nearly \$1 million the last 4 years. I am the only employee, and in that

time my boss gave me one single bonus for three hundred dollars. Nothing is forcing them to support us, they just replace us.

My father had multiple homes, multiple sports cars, clothes, watches, you name it... with a middle school education when he was the age I am right now. He had his 2nd child at my age with not a financial care in the world.

The economy here is unsustainable. There's going to be many, many more like me. I have not gone out once on a Friday night in over 12 years. All I do is sit and stare at the wall and try to not spend money. It's extremely unhealthy. Even if everything goes right, I still end up about \$140 in the hole. I find myself trying to do things like preserve lettuce to save money. Lettuce.

I'm just letting you guys know the realness of this. This is upsetting our residents, not just in general, but people are upset at how I've been treated, as I'm known as a standup + give-back person around town. They're upset that they're seeing me work so hard to help the community and yet getting absolutely nothing in return for it. They're upset that I financially can't have kids.

They also say it's not even worth letting you guys know because you're all on your high horses and don't care.

Landlords want us to make 2.5x or 3x the rent. Who makes \$6k/month and wants to live in a studio? Landlords are also charging \$50/application, the biggest scam ever: They take 100 applications and pocket 5 grand. Additionally, nobody I know has money to put towards 10-20 applications. This is all absurd! I'm going to be forced to move to Jacumba and commute an hr to La Mesa, nothing green about that (There are all kinds of "Green" bs things going on in La Mesa).

You guys have severely miscalculated the wages we should all be being paid.

Not everyone is an economics major like me. You can't expect the people of our community to be so responsible with money. I had to be beyond responsible with money the last 20 years...I've missed birthdays, funerals, friends dying, all because maybe one drive to the cemetery might mean not having enough gas to make it to work. There are many studies on the effects of long term paycheck to paycheck and the effect it has on people's health. We don't understand what is the harm in letting us make more money.

Another example: Right now there's a home for sale in El Cajon at 1633 Monarch Ridge. It's a pretty normal looking home: It has walls, a door, trees, a couple of garages. It's a nice home, but there are many just like it. It's nice, but it's not the Taj Mahal. It has 5 bedrooms. What's the price? IT'S 1.9 MILLION DOLLARS. If you put 300k down, the mortgage is a true bargain at only : \$13,896/month! LMAO! Oh and don't forget, the bank wants you to make 2.5x the mortgage. Who the heck makes \$35K/month??!

Who makes that much and wants to live in El Cajon?!?

OH BOYYYYY! WE HAVE PROBLEMS UP AHEAD!!!!

Soon there will be a wave of homeless because we just don't have any money, and we are so incredibly low on low income units that they will not save us. We have been too slow at putting them up. The Amish put up 12 homes in two days for the North Carolina Hurricane Victims. I do not see why you guys are unable to keep the entire housing problem at bay/in line.

WHY THE HECK ARE TINY HOMES BANNED???????????

And to be honest, the wages are so bad that had my friend not bought me a car, I would still be reluctantly riding my bike to work, 6 miles a day, 30 miles a week, getting hit by cars, shot at, all that. The whole time, La Mesa is actively doing everything they can to get us out of our cars and onto bikes. They no longer hide it, as they are now making statements in their email which indicate that they want bikes to be the main source of travel here for some reason...on our huge, hillous mountains. Imagine asking some 70 year old lady to take her Cosco groceries home on a bike. Everytime I look out of my window at work and see some poor bluehair riding a bike up Baltimore Drive, I literally shed a tear. These people are our veterans, and grandparents...they work their whole life and are left with: riding a bike around? And La Mesa is PROMOTING THAT? HOW ABOUT NO!!!!

The policies in this town have turned my life, and alot of people I know into a living hell. All I want to do is save up and leave at this point and I can't, I'm too busy getting fined for not having health insurance, or paying \$20 for a quesadilla.

Just giving you guys the scoop, you will be seeing me with a cardboard sign on the median soon I'm sure...

**RE: Concerns and Recommendations Regarding the Proposed Cannabis Program for Fallbrook and Unincorporated Areas of San Diego County**

Honorable Members of the San Diego County Board of Supervisors,

I am writing to express my concerns and recommendations regarding the proposed cannabis program for the community of Fallbrook and the unincorporated areas of San Diego County.

The importance of reconsidering cannabis cultivation in the county is underscored by the experiences of other municipalities that have allowed cannabis cultivation for years. Many of these communities have encountered lasting negative impacts, which have led to the revision of their programs. It is clear that cultivation should be removed from all alternatives until up-to-date, reliable analyses and studies can be conducted to better understand the long-term consequences for our region.

Additionally, I would like to draw your attention to a recent **landmark ruling** in Carpinteria, where a class action lawsuit was filed due to the nuisance caused by the pervasive odor of cannabis cultivation. This ruling has far-reaching implications and should be carefully considered.

Beyond these considerations, I would also like to highlight several critical environmental and public health impacts that have not been sufficiently addressed in the Draft Environmental Impact Report (DEIR). These concerns affect not only the residents of Fallbrook but all property owners, businesses, and communities throughout the unincorporated areas of San Diego County. In particular, I believe the following areas require more thorough analysis and action:

1. **Impacts on rural roads and infrastructure.**
2. **Increased risk from impaired driving** due to cannabis consumption at lounges and temporary events.
3. **Negative environmental effects of cannabis cultivation** on local utilities, rural aesthetics, and surrounding residents and businesses.
4. **Impacts from outdoor temporary events** associated with cannabis.
5. **Cannabis odors** and their detrimental effects on neighboring properties.
6. **Negative effects on other crops** in the area.

7. **Impacts on law enforcement, first responders, and public services** due to an increase in cannabis-related incidents.

Given these serious concerns, I strongly recommend that the DEIR be revised to include a more comprehensive and up-to-date analysis of these issues. Public notices regarding the project and the DEIR should also have been sent to all property owners, residents, and businesses within the unincorporated areas, as the original notices were insufficient.

Before moving forward, I respectfully request that the entirety of the San Diego County Socially Equitable Cannabis Program and its associated projects be paused for a comprehensive reevaluation. This should be based on current data, including the comparative program failures and court rulings from other counties and cities. Only through this careful review can we ensure the protection of our communities and environment.

Thank you for your attention to this important matter. I look forward to your response and am happy to provide further input as necessary.

Apparently, 214 acres on a former Golf Course are coming available and they are proposed for a sand mine. Why do we need all that space for a sand mine? This may be a good opportunity to substitute for the twice rejected Lemon Grove shelter idea.

The residents do not want a sand mine there. Maybe there would be less opposition to a congregate homeless shelter. In addition to the potential health effects, increased traffic impacting emergency vehicle routes, a large scale industrial project will probably cause excessive noise levels. It is also not near a health facility, across from a liquor store, or as close to a school.

### **Rancho San Diego residents rail against proposed project to turn defunct golf course into sand mine**

Residents of Rancho San Diego voiced strong opposition to a proposed plan to convert the Cottonwood Golf Course into a sand mine during a packed community planning group meeting on Wednesday night.

The Valle de Oro Community Planning Group unanimously voted to recommend denying the project, citing concerns over health, traffic, and environmental impacts.

The controversial proposal aims to mine 4.7 million cubic yards of sand over a decade on 214 acres of the current golf course site. Dozens of community members attended the meeting to express their disapproval of the plan, which they believe does not align with the character of their neighborhood.

Opponents highlighted potential health effects, increased traffic impacting emergency vehicle routes, and environmental concerns as primary reasons for their opposition. The planning group's vote to recommend denying the project reflects these widespread community concerns.

In response to the opposition, the project's developer provided a statement to CBS 8, arguing that the proposal would "ultimately transform a defunct golf course property into 200 acres of permanent, preserved open space for the community to enjoy." The developer also emphasized the regional benefits of creating a local sand supply, stating it would "reduce the increased costs and environmental damage caused by trucking sand in from outside the region and Mexico."

Despite the developer's claims, residents remain unconvinced about the project's merits and its compatibility with the surrounding area.

The proposal will next be reviewed by the San Diego County Planning Commission, which is expected to vote on whether to recommend the project move forward on April 18.

#### Fix 2: Oversight Now

State oversight—track 611,075—break the Registrar's monopoly. Anderson, Desmond—your voters see it—Districts 2 and 5 lost 120,000, 150,000 in 2021—611,075, 1,000 fakes—unverifiable. Lawson-Remer—your reform can end this—vote yes. Montgomery Steppe—'23's 73,401—5,000 untracked—611,075's bigger. Every year since '97—NVRA—holes grow—611,075 proves it. #### Why Act?

The California Constitution, Article I, Section 28, confers certain rights to victims of crime as they are defined in the law. Those rights include:

**Defendant**

protected from the defendant and persons acting on behalf of the defendant.

**3. Victim Safety Considerations in Setting Bail and Release Conditions**

To have the safety of the victim and the victim's family considered in fixing the amount of bail and release conditions for the defendant.

**4. The Prevention of the Disclosure of Confidential Information**

To prevent the disclosure of confidential information or records to the defendant, the defendant's attorney, or any other person acting on behalf of the defendant, which could be used to locate or

I'm here to pitch hemp batteries as the game-changer to hit our 2024 Climate Action Plan's net-zero goal by 2045. This isn't a side project—it's the key to slashing emissions, meeting state mandates, and leading the green charge. Let's dive in.

The Climate Crisis: Our 2024 CAP says it plain: unincorporated San Diego County and our operations must hit net zero by 2045—85% emissions cuts by then, 44% by 2030. Lithium-ion batteries? They're a disaster—mining burns 500,000 gallons of water per ton, spews toxic sludge, and props up a \$80/kg price tag that's climbing. Alkaline AAs? Billions rot in landfills, poisoning our soil. Our fleet, facilities, and communities are chained to this mess, and it's dragging us off the net-zero cliff.

Hemp Batteries—Our Green Answer: Hemp's not a gimmick—it's proven. Clarkson University's data shows hemp supercapacitors pumping out 10,000 watts per kg—20 times lithium's power—charging in seconds. Labs hit 80 Wh/kg today; push it to 300 Wh/kg, and we're past lithium's 250 Wh/kg. They last 100,000 cycles—think one battery outliving decades of throwaways. Grown locally, hemp sequesters CO<sub>2</sub>, skips the mines, and costs \$1/kg raw. This is how we decarbonize.

Tying to Our CAP Goals:

Fleet Electrification: CAP Measure T-2 demands zero-emission vehicles. Hemp powers quick-charge EVs—scooters now, trucks soon. A 300-mile range, 30-second charge slashes our 36.5 million commuting miles from 2022.

Energy Efficiency:

Measure E-1 pushes renewable energy. Hemp backups for solar grids deliver instant power, no lag—perfect for peak demand in our 3,570 square miles of unincorporated land.

Community Equity: CAP's justice focus—health, jobs, quality of life—gets a boost. Hemp farms and plants here mean green careers, not cobalt scandals, for our 454,599 residents.

Carbon Sinks: Measure A-1 wants more trees, land conservation. Hemp's carbon-negative growth doubles down—2-4 tons of fiber per acre, soaking up GHG while it scales.

The Numbers:

A \$5 million pilot gets us a hemp lab and 100-acre farm by 2026. Lithium's at \$100-150/kWh, volatile. Hemp could hit \$50/kWh, saving millions as we scale to 2045. 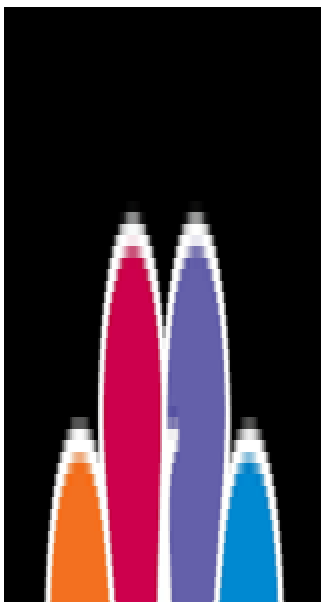

All this makes a huge difference dollarwise in what we spend, and what you can afford. So please re-revise the budget if you haven't already.

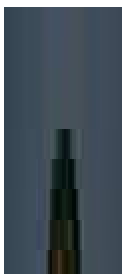

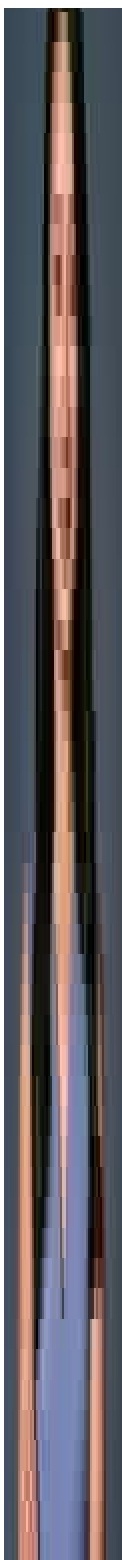

**Stagflation? Fed sees higher inflation and an economy growing by less than 2% this year**

Federal Reserve officials slashed their economic outlook in the latest projections

released Wednesday, seeing the U.S. economy growing at a pace lower than 2%.

The rate-setting Federal Open Market Committee downgraded its collective outlook for economic growth to 1.7%, down from the last projection of 2.1% in December. In the meantime, officials hiked their inflation outlook, seeing core prices growing at a 2.8% annual pace, up from the previous estimate of 2.5%. The moves suggested the central bank sees the risk of a stagflation scenario, where inflation rises as economic growth slows.

In a statement, the FOMC noted the “uncertainty around the economic outlook has increased,” adding that the Fed is “attentive to the risks to both sides of its dual mandate.”

Fears of an economic slowdown and inflation reacceleration have increased significantly as President Donald Trump’s aggressive tariffs on key U.S. trading partners are expected to raise prices of goods and services and dent consumer spending.

“Inflation has started to move up now. We think partly in response to tariffs and there may be a delay in further progress over the course of this year,” Fed Chair Jerome Powell said at a news conference. “Overall, it’s a solid picture. The survey data both household and businesses show significant large rising uncertainty and significant concerns about downside risks.”

For now, the Fed still expects to make two rate cuts for the remainder of 2025, according to the median projection, even as the inflation outlook was raised.

The so-called dot plot indicated that 19 FOMC members, both voters and nonvoters, see the benchmark fed funds rate at 3.9% by the end of this year, equivalent to a target range of 3.75% to 4%. The central bank kept its key interest rate unchanged in a range between 4.25%-4.5% on Wednesday.

Still, their view has leaned more hawkish in their rate projection, with four members seeing no rate changes in 2025. At the January meeting, just one official foresaw no changes in interest rates this year.

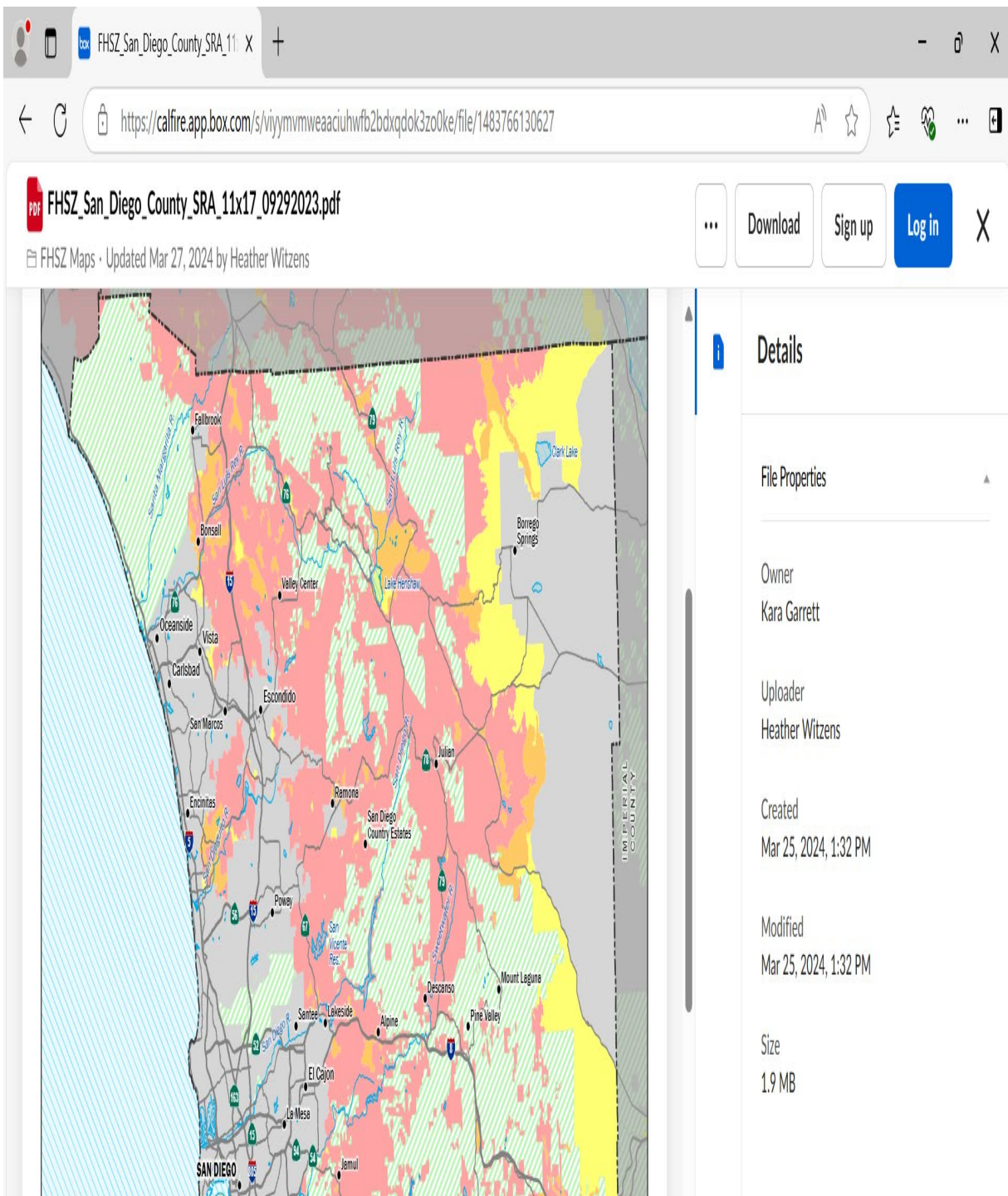

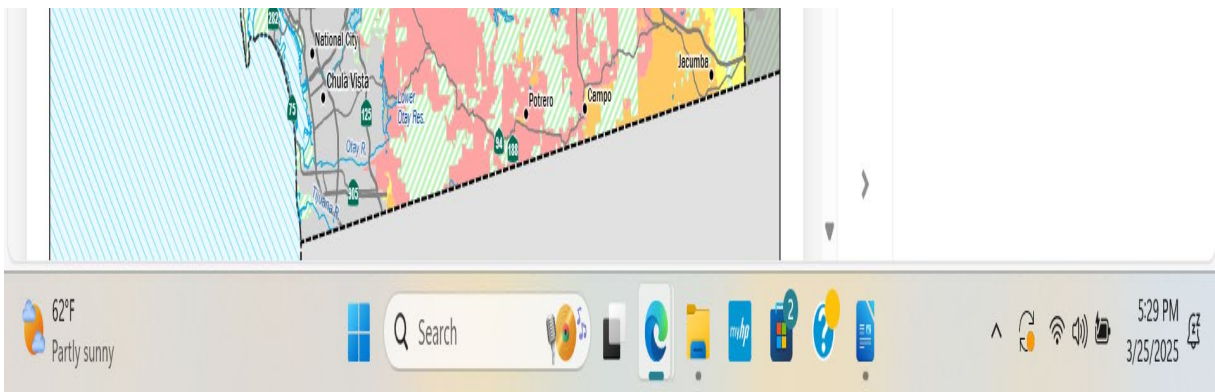

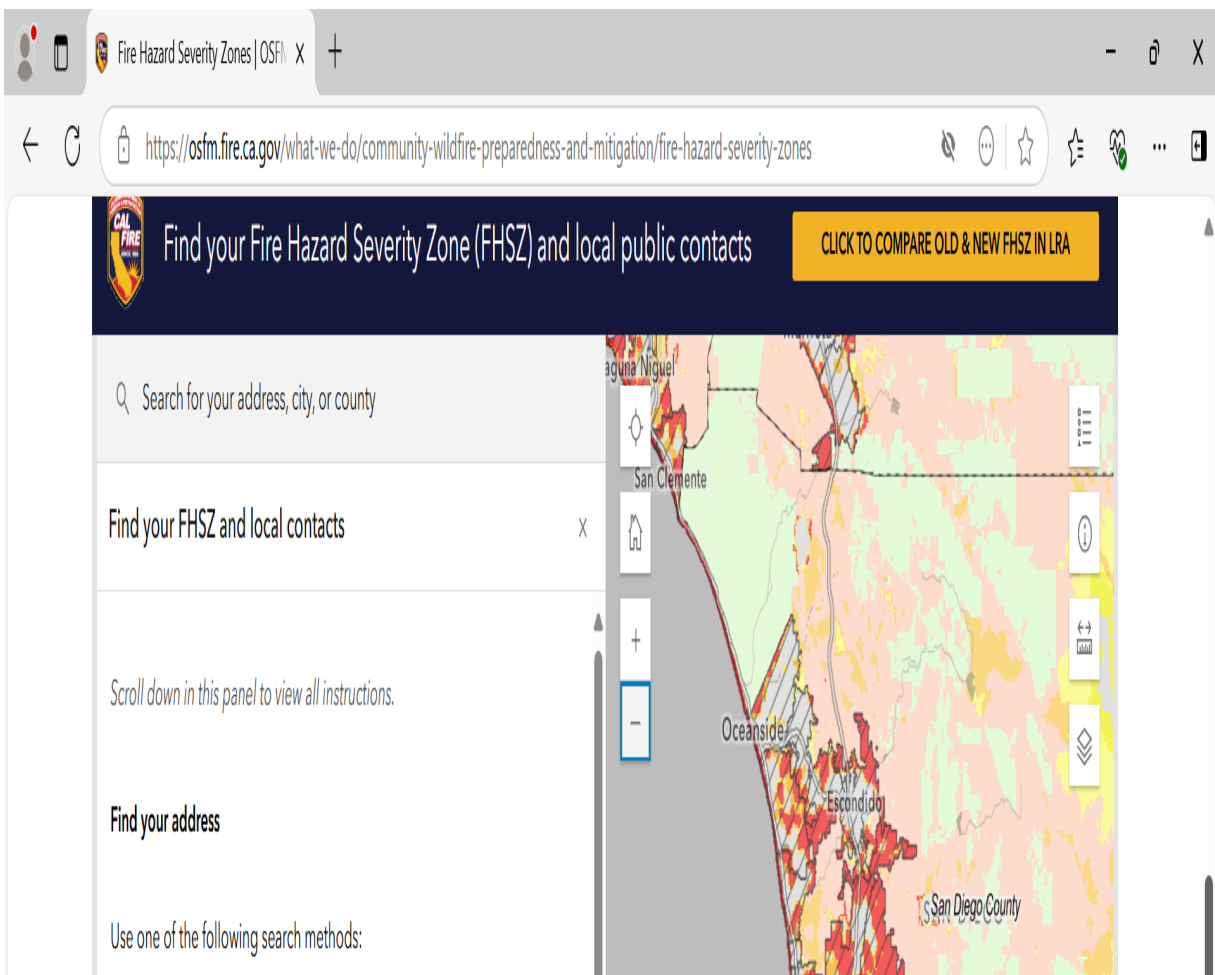

This map is State Responsibility Fire Hazard Severity





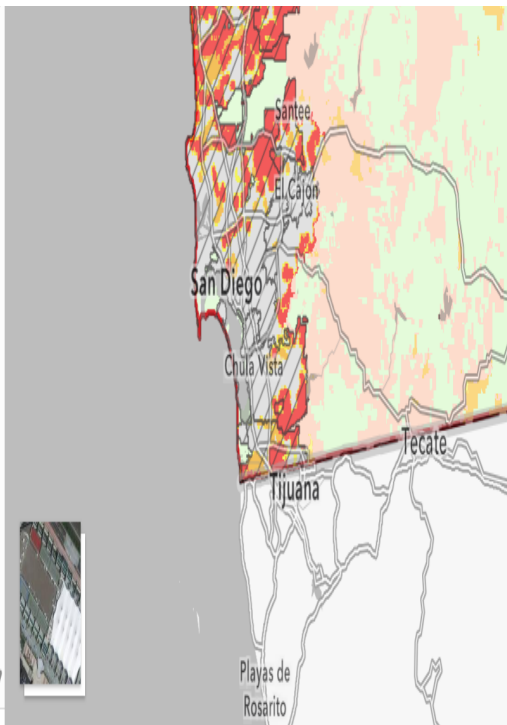

## Trump administration says it will pull back billions in COVID funding from local health departments

Federal health officials said Tuesday they are pulling back \$11.4 billion in COVID-19-related funds for state and local public health departments and other health organizations throughout the nation.

[Not just ending future funding.]

“The COVID-19 pandemic is over, and HHS will no longer waste billions of taxpayer dollars responding to a non-existent pandemic that Americans moved on from years ago,” the U.S. Department of Health and Human Services said in a statement.

The statement said the Centers for Disease Control and Prevention expects to recover the money beginning 30 days after termination notices, which began being sent out on Monday.

Officials said the money was largely used for COVID-19 testing, vaccination and global projects as well as community health workers responding to COVID and a program established in 2021 to address COVID health disparities among high-risk and underserved patients, including those in minority populations. The move was first reported by NBC News.

[OMG – Reverse equity.]

Lori Freeman, CEO of the National Association of County & City Health Officials, said much of the funding was set to end soon anyway. "It's ending in the next six months," she said. "There's no reason — why **rescind** it now? It's just cruel and unusual behavior."

**[Not rescind, PULL BACK!]**

In a related move, more than two dozen COVID-related research grants funded by the National Institutes of Health have been canceled. Earlier this month, the Trump administration shut down ordering from covidtest.gov, the site where Americans could have COVID-19 tests delivered to their mailboxes for no charge.

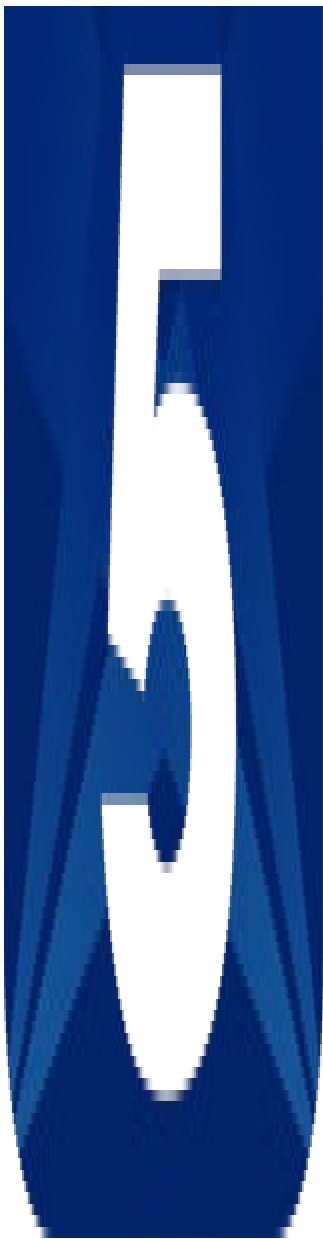

## **San Diego County loses \$40M in funds just before new public health lab opens**

**SAN DIEGO (FOX 5/KUSI) —** San Diego County will not receive \$40 million of public health funding promised by the Centers for Disease Control and Prevention (CDC), County Supervisor and acting Board of Supervisors Chair Terra Lawson-Remer announced Thursday in a news release.



According to the release, the county was notified just last week that the CDC would pull back on multiple funding streams that were previously awarded through fiscal year 2025-2026.

The impacted streams fall under the Epidemiology and Laboratory Capacity (ELC) program, the Immunization and Vaccines for Children program, and the COVID-19 Health Disparities Grant.

Lawson-Remer said the county was awarded \$174 million, but recently learned that \$40 million will no longer be available “due to the CDC’s abrupt 30-day closeout period.”

The announcement comes just weeks before the county was preparing to debut its new Public Health Lab in May. The project was first announced years ago, and is slated to open in Kearny Mesa.

The \$93 million, 52,000-square-foot project was designed to expand the county’s response to transmissible diseases and reduce the need for out-of-county corporate labs.

It was funded, in part, by local dollars. However, the county supervisor said the lab needs federal support to ensure the facility will be able to provide services as planned.

“We built the lab. We planned responsibly. We kept our end of the deal. Now the federal government is walking away from theirs — and San Diego families are the ones paying the price,” said Lawson-Remer. “This isn’t just bad policy — it’s sabotage disguised as efficiency, and it leaves San Diego taxpayers holding the bill.”

The grants were meant to support \$17 million in capital costs as well as lab equipment.

Over 90 public health positions have been impacted by the cuts, according to the release.

A few of the programs now at risk due to the lack of funding, according to Lawson-Remer, are a mobile testing unit for community outbreaks, in-shelter flu and hepatitis vaccinations, public health data system and staffing for epidemiologists and health investigators.

The loss of grant funding underscores the local need for public health services. The county announced a large hepatitis A outbreak in March 2017, with some cases traced back to November 2016. Due to the scale of the outbreak, the county declared a local health emergency on Sept. 1, 2017.

Before it officially was declared over on Jan. 23, 2018, the outbreak resulted in nearly 600 cases and 20 deaths.

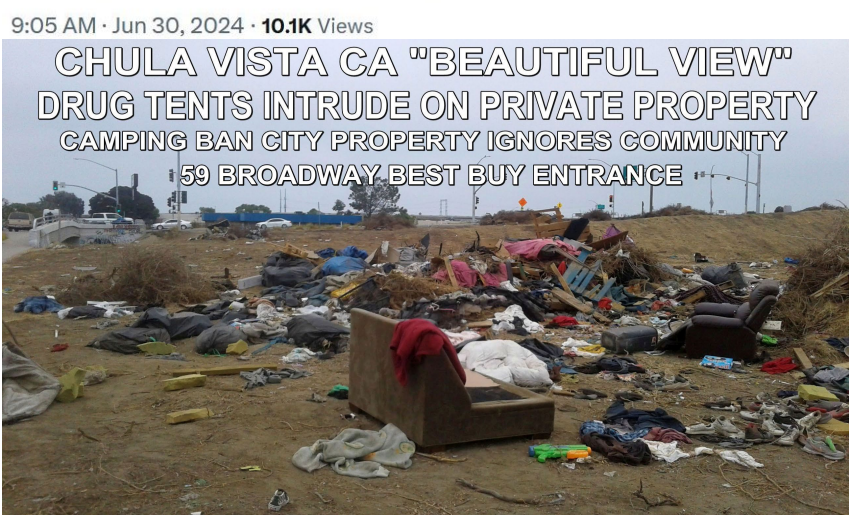

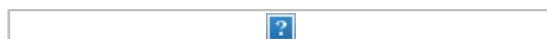

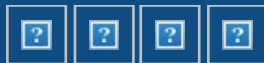

## SAND-MAN IN YOUR FACE

The UT says the current sand project is 3 times the amount of sand and 10 times as expensive as previous projects. It also says that the current project will dump sand on Oceanside and Dana Point.

**So, a \$260 million project on about 18 beaches, about \$14.5 million per beach. OC has 3 beaches, about \$40 or 50 mil. Will they compensate us?**

**OC has its own counterpart to SANDAG. Why are they coming to us anyway?**

**Apparently, plans are to get the sand from the ocean. That would be major disruption to marine life and also, by the way, marine researchers, divers, and maybe even our fresh fish supply.**

It also says southern Oceanside Beach is eroded down to the bare rock, raising the issue of how often does this need to be done, will the costs keep increasing, and is it practical? Also are we mining our area for sand destined for other Counties outside of SANDAG jurisdiction.

## **Biggest beach sand restoration yet planned by SANDAG**

**San Diego County's next regional beach restoration project will be its largest yet, delivering three times the sand previously pumped onto the coastline and at 10 times the cost, planning officials said.**

**"The time is right to do another regional sand project," said Keith Greer, deputy director of regional planning at the San Diego Association of Governments, the lead agency for the project.**

**In 2001, the agency spread a total of 2.1 million cubic yards of sand at 12 different spots along the eroding shoreline from Oceanside to Imperial Beach at a cost of \$18 million. A smaller project in 2012 generated about 1.5 million cubic yards for \$26 million. State and federal grants paid for most of both projects.**

**[Money may not be there this time, so who pays? Us, tourists, take away from city uses for hotel tax?]**

**Planning for a third regional sand replenishment began almost two years ago. Two Orange County cities — San Clemente and Dana Point — have joined the project for the first time, along with all of San Diego County's coastal cities.**

**[Board aware, these are not in jurisdiction?]**

**This time the collaborative effort is expected to place about 5.8 million cubic yards of sand on 15 sites in San Diego County and three in Orange County. The cost also will go up, to about \$260 million, most of which again would have to be covered by state and federal grants.**

**Studies show the expense is justified, SANDAG officials said Thursday in a presentation to the agency's Shoreline Preservation Working Group of elected officials from the coastal and bayfront cities, the county, and representatives of the U.S. Navy and the Port of San Diego.**

**"There is a need to maintain San Diego's beaches to sustain its economy," said Courtney Becker, a SANDAG associate regional planner.**

**Oceanside, where the southern two-thirds of the city's coastline has eroded to bare rocks, will get the largest single share of the sand — about 1 million cubic yards — almost four times the volume obtained from the annual harbor dredging completed in 2024.**

**[Is this since the 2012 project – 13 years – and as sea levels change, we can expect the pace off erosion to increase.]**

**Carlsbad would get 240,000 cubic yards for its northern beaches and 300,000 for its more eroded southern beaches. Farther down the coast, deposits of 105,000 to 300,000 cubic yards each are proposed at the mouth of Batiquitos Lagoon, Leucadia, Moonlight Beach and Cardiff in Encinitas, also at Solana Beach and Del Mar.**

**Torrey Pines, Tourmaline Beach and Mission Beach in San Diego, Coronado Shores, Glorietta Bay, and Imperial Beach also would get sand.**

**[Glorietta Bay, not even an ocean beach?]**

In Orange County, San Clemente State Beach can expect 800,000 cubic yards, San Clemente's North Beach would get 250,000 and Dana Point would get 500,000 under the proposal.

The agency is studying about six potential sites in the ocean just outside the surf zone that could provide the sand, including some that were used for the previous regional replenishments.

A feasibility study for the project is nearing completion and should be released to the public in July, Becker said. After that a second phase will begin, engineering and environmental work that is expected to cost about \$3 million and is so far unfunded.

The third and final phase is construction, which could only take place once more funding becomes available.

SANDAG recently applied for a \$5.2 million state grant that would help pay for the project, she said. Acceptance of the grant requires a 15% local match.

**[Taxpayers on the hook for \$750,000 - and that leaves about \$255 million to pay for.]**

"We recognize that local jurisdictions can not pay for this alone," Becker said. "This needs to be a local, state and federal share."

**[But in the current and future economy, will they pay?]**

Ideally the regional replenishment would be done every 10 years, she said. Most of the sand from the 2012 placement has long washed away, leaving much of the county's coastline narrow and rocky.

**[No accounting for increased pace of erosion.]**

Past projects show that less sand applied more frequently, and in the right places, does a better job of protecting the coastline than long waits between big deposits, said Reinhard Flick, an oceanographer with Scripps Institution of Oceanography.

"That should be taken into account," said Flick, who has studied waves, tides, sea levels and coastal erosion since 1969. "This is crucially important, that we use the best available science."

**[Why pay a huge cost for something that might not pan out?]**

All of Southern California's coastal cities share the problem of beach erosion, the result of widespread development that has stopped the natural supply of sand from rivers and crumbling seaside bluffs. Sea-level rise and more frequent, powerful storms shrink the shoreline further.

Encinitas, Solana Beach and San Clemente all received the first fruits of major U.S. Army Corps of Engineers replenishment projects that, after decades of planning, began last year and are expected to continue periodically for 50 years.

**[So is SANDAG duplicating existing efforts?]**

Oceanside has been planning its own sand replenishment and retention project for more than two years and is in final design and engineering stages.



**“We need to not just place sand, but to permanently change the shape of the coastline to keep that sand,” Jayme Timberlake, Oceanside’s coastal zone administrator, told the shoreline working group.**

**The proposal includes the creation of two artificial headlands or small promontories extending out on the beach to hold the sand in place. Also, the city intends to build a chevron-shaped artificial reef in the water to deflect some of the incoming wave energy.**

**Like the regional projects, the Oceanside effort needs grant funding and approvals from multiple agencies.**

**And in Carlsbad, maintenance dredging at the mouth of the Agua Hedionda Lagoon is nearing a finish for the first time in four years. That work began in February and is placing up to 400,000 cubic yards of sand on beaches north and south of Tamarack Avenue.**

**[More duplication?]**

**Originally the Agua Hedionda Lagoon was dredged every few years by the San Diego Gas & Electric Co. to provide seawater to cool its Encina power plant.**

**Now the job is the responsibility of operators of the Carlsbad desalination plant, which filters seawater from the lagoon and adds it the potable water distributed by the San Diego County Water Authority.**

California has long been recognized as a global center for innovation, technological leadership, and forward-thinking governance. From the rise of the internet to the birth of artificial intelligence, this state has led the world in pioneering new ways of thinking, building, and connecting. Now, another pivotal moment is upon us—and this one concerns the very core of democratic governance: transparency.

Cities and counties across California are being invited to lead the state into a new era by adopting a simple but transformative policy—making government employee emails and internal documents public by default. This is not just a policy shift; it is an essential step toward aligning the mechanisms of government with the realities of 21st-century technology and the expectations of an informed public.

Historically, public access to government communications has been constrained by cumbersome systems—requiring individual requests under the California Public Records Act (Gov. Code § 6250 et seq.), followed by slow, selective disclosures. These constraints were understandable in an era when comprehensive data review was difficult, time-consuming, and costly. But that era is over.

Modern artificial intelligence tools, now widely available and operable on personal computers costing less than \$1,500, allow individuals to analyze massive volumes of text, email, and documentation with speed and context. What was once an overwhelming firehose of unstructured information is now something any informed citizen can explore, synthesize, and evaluate. The power to hold institutions accountable, spot trends, and bring informed ideas to the table no longer resides solely within government agencies or media outlets—it belongs to the public.

The consequences of maintaining the status quo are becoming clearer with each passing month. A default-to-closed model—requiring residents to guess what to ask for, wait weeks or months, and receive incomplete or redacted fragments—will increasingly be seen as archaic, exclusionary, and deliberately obstructive. The longer this model is defended, the worse it will look in the eyes of a public that is becoming rapidly more capable of processing full datasets and more aware of its right to access the business of government.

No law prohibits proactive, comprehensive transparency. In fact, the California Constitution and the Public Records Act encourage it. Article I, Section 3(b) of the state constitution affirms the public's right of access to information concerning the conduct of the people's business. The legal framework is not a barrier—it is an open door. What has been missing is

the will to walk through it.

This is the time to act. This is the opportunity to lead. Jurisdictions that move now to implement systems for default public access will not only earn public trust—they will set a standard for modern governance that others will eventually have no choice but to follow. By contrast, those who delay or resist this transition risk appearing increasingly out of touch, reactive, and dismissive of the public's capacity for participation.

This letter, also being shared publicly, is both an invitation and a marker in time. Every city and county now has the chance to be among the first to embrace a future where transparency is not a burden, but a baseline—where oversight is not feared, but welcomed—where the people of California are trusted with the information they rightfully own.

The age of artificial intelligence makes this transition inevitable. The only question is who will lead it.

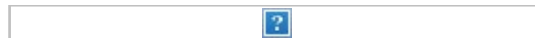

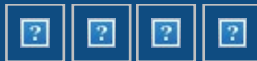

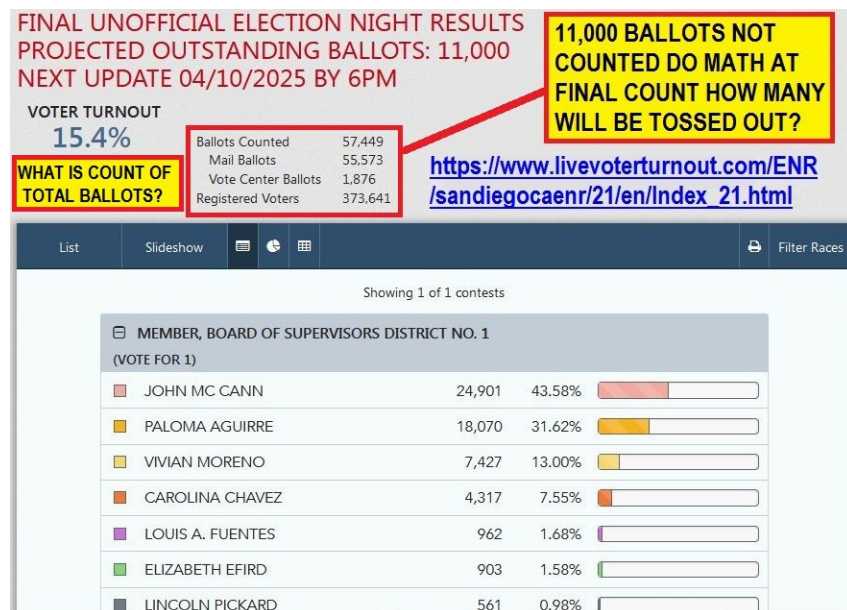
