INTRODUCTION

The information provided in this report is derived primarily from documents developed at the time the District was formed and from data provided by the County or accessed through the County. The information sources include the Rate and Method of apportionment, annual budget, debt service schedule(s), and special tax delinquency data. The development status, prepayments and historical information were accessed through the County and/or the developer and are maintained by Willdan Financial Services.

The Mello-Roos Community Facilities Act (“Act”) of 1982 came about as a response to the lack of adequate financing for public capital facilities and services in the post-Proposition 13 era. State Legislators Mello and Roos sponsored this Bill, which was enacted into law by the California Legislature and is now Sections 53311 through 53363 of the California Government Code. The Act authorizes a local governmental agency, such as a school district or city, to form a Community Facilities District (“CFD”) or (“District”) within a defined set of boundaries for the purposes of providing public facilities and services. A CFD is formed for financing purposes only and is governed by the agency that formed it.

A. FORMATION

The Board of Supervisors of the County of San Diego (“Board”), in the State of California, did, pursuant to the terms and provisions of Chapter 2.5 of Part 1, of Division 2, of Title 5 of the Government Code of the State of California, as amended (the “Act”), adopted a Resolution of Intention for the proposed formation of the District.

B. BOUNDARIES AND DEVELOPMENT SUMMARY

CFD No. 2019-01 encompasses approximately 389 gross acres of land in the County of San Diego. The project includes approximately 189 gross acres for residential development (458 single-family residential lots and 358 multi-family lots, 122.6 acres of open space, 47.6 acres of agriculture land, 0.5 acres of wetland buffer, 9.1 acres of community park, 1.5 acres of pocket park, 1.8 acres of cultural conservation area, 12.7 acres of school site, and 4.3 acres of basin.

C. BONDS

Bonds for this project will be issued through California Statewide Communities Development Association (CSCDA).

D. FINANCED SERVICES

The purpose of CFD No. 2019-01 is to provide revenue for the provision of approved county services, Flood Control Services, North County Fire Protection

District Services, and Administrative Services, for the benefit of properties within the District boundaries. All these services to be provided to properties within the boundaries of the CFD, and funded by the CFD, are in addition to services already provided to the areas to be included within the CFD boundaries.

I. LEVY SUMMARY OVERVIEW

C. DELINQUENCY MANAGEMENT ACTIONS

There were no delinquency management actions performed for Fiscal Year 2024/2025.

III. SPECIAL TAX LEVY AND METHOD OF APPORTIONMENT

The methodology employed to calculate and apportion the special tax is in accordance with the document entitled Rate and Method of Apportionment (“RMA”). The RMA is hereby referenced and summarized but not included in this report, however the official document can be requested and provided by the City’s special tax administrator Willdan Financial Services.

A. RATE AND METHOD OF APPORTIONMENT

Pursuant to Section F of the Rate of Method of Apportionment, commencing with Fiscal Year 2022/23 and for each following fiscal year, the CFD administrator shall determine the Special Tax Requirement and shall levy the Special Tax until the total Special Tax levy equals the Special Tax Requirement.

Special Tax A shall be levied on each Assessor’s Parcel of Developed Property up to 100% of the applicable Assigned Special Tax. If additional monies are needed to satisfy the Special Tax Requirement for County Services after the first step has been completed, the Special Tax shall be levied Proportionately on each Assessor’s Parcel of Undeveloped Property at up to 100% of the Maximum Special Tax for Undeveloped Property.

Developed Property means for each fiscal year, all Taxable Property, exclusive of Taxable Public Property and Taxable Property Owner Association Property, for which a building permit for new construction was issued after January 1, 2008 and on or before May 1 of the Fiscal Year preceding the Fiscal Year for which the Special Taxes are being levied.

Special Tax B commencing with Fiscal Year 2022/23 and for each following Fiscal Year, the Board or its designee shall levy the Special Tax B until the total Special Tax B levy equals the Special Tax Requirement for Flood Control Services. The Special Tax B shall be levied Proportionately each Fiscal Year on each Assessor’s Parcel of Developed Property at up to 100% of the applicable Maximum Special Tax B as needed to satisfy the Special Tax Requirement for Flood Control Services.

Further notwithstanding the above, under no circumstances will the Special Tax B levied against any Assessor’s Parcel of Residential Property for which a Certificate of Occupancy has been issued be increased by more than ten percent above the amount that would have been levied in that Fiscal Year had there

never been any such delinquencies or defaults as a consequence of delinquency or default by the owner of any other Assessor's Parcel within CFD No. 2019-01.

Commencing with Fiscal Year 2022/23 and for each following Fiscal Year, the Board or its designee shall levy the Special Tax C on all Developed Property in an amount equal to 100% of the applicable Assigned Special Tax C to fund Fire Services.

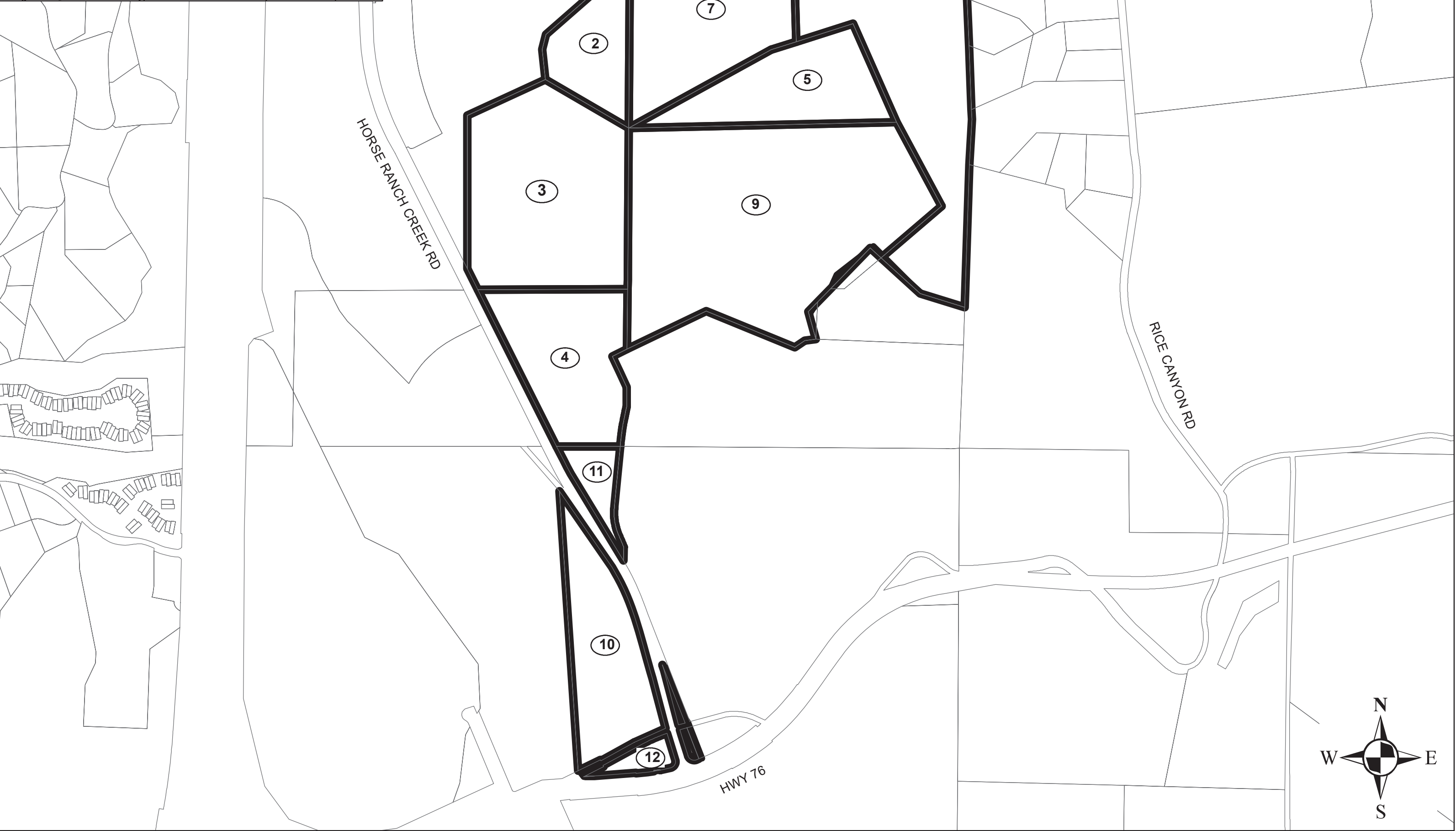
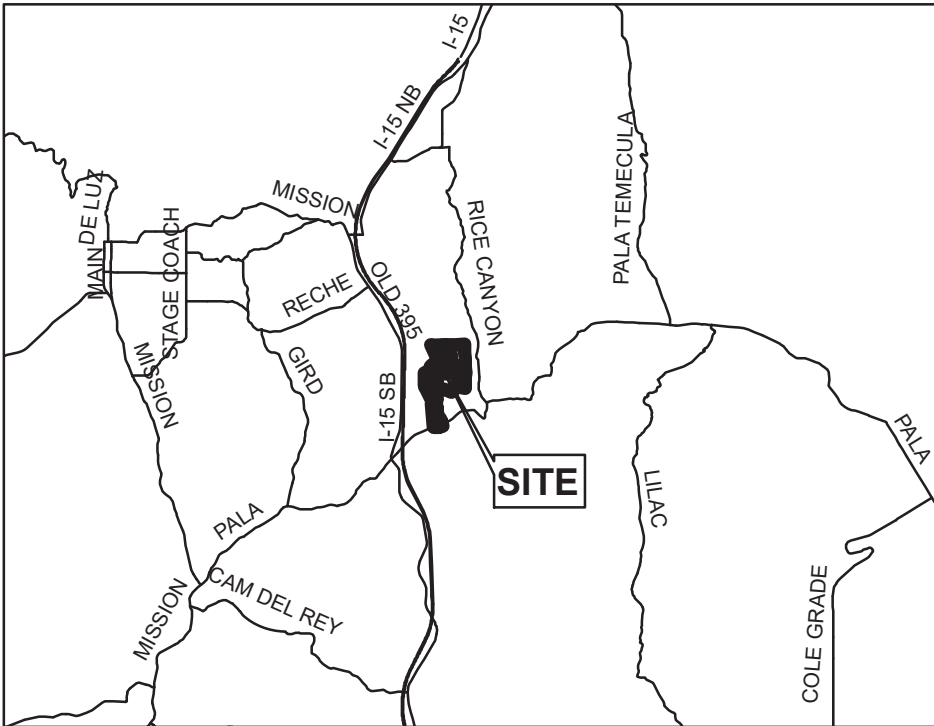

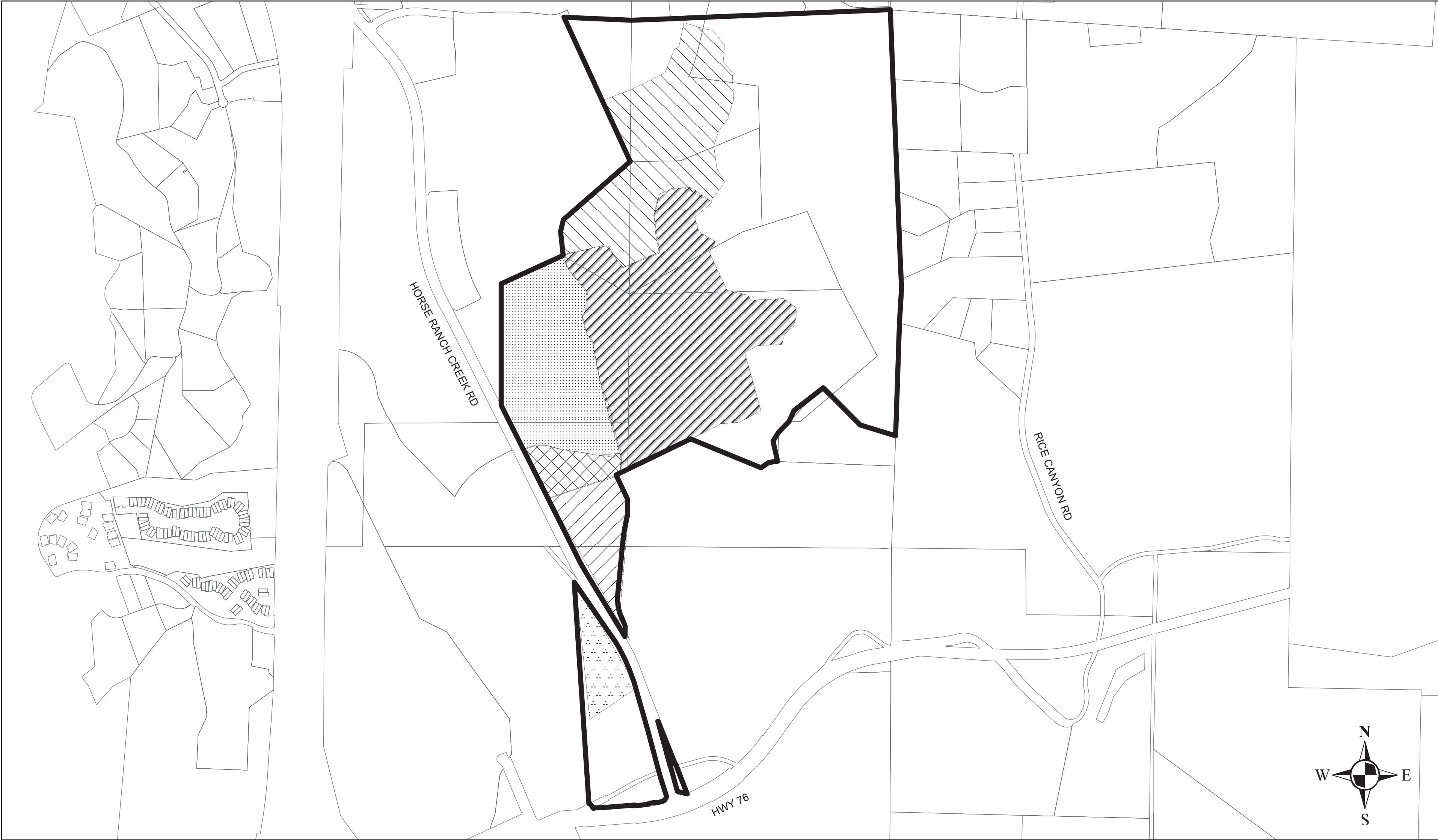
