On behalf of PATH (People Assisting The Homeless), I am writing in support of the motion from Supervisors Joel Anderson and Terra Lawson-Remer, designing San Diego County's first shallow rental subsidy program for older adults who are low-income, rent-burdened, and at-risk of homelessness.

As you know, PATH is California's largest homeless service provider, serving 13% of the State's homeless population in six regions, 150 cities, and 60 locations. We operate five supportive housing sites and 24 programs in San Diego County, where we provide on-site supportive services for people as they transition out of homelessness.

Homelessness is devastating for any individual, but the trauma of unsheltered life is especially hard on our elders. Older adults experiencing homelessness or housing instability fall through gaps in the system, with unique needs requiring specialized gerontological training that service providers sometimes lack. Many older adults report feeling unsafe at emergency shelters, where acute health risk factors can go overlooked or occasionally exploited.

Our staff work hard to end homelessness, but our jobs are made easier when we can prevent people from becoming homeless in the first place. Because many older adults live on a fixed income and often confront technological or mobility obstacles, housing assistance programs that emphasize simplicity and remote access are crucial. This proposed rental subsidy is straightforward and, if implemented properly, likely to succeed.

We especially appreciate the referral motion's focus on early intervention to keep people in their homes. Early intervention results in the least amount of trauma for the individuals involved and is cost-effective when compared to emergency shelter operating costs. Ending homelessness must include preventing people from becoming homeless at all.
