**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO TO
CONDUCT A SPECIAL ELECTION TO FILL THE VACANCY FOR THE FIRST
SUPERVISORIAL DISTRICT SEAT**

WHEREAS, on December 20, 2024, District 1 Supervisor Nora Vargas notified the County of San Diego that she would not be pursuing a second term that was set to begin at 12 noon on January 6, 2025; and

WHEREAS, on January 6, 2025, at 12 noon, the First District Supervisorial seat was vacated; and

WHEREAS, on January 14, 2025, pursuant to the County of San Diego Charter section 401.4 and County of San Diego Board policy A-39, "Process to Fill Vacancies on the Board of Supervisors," the Board of Supervisors voted to fill the vacant seat by special election; and

WHEREAS, on January 14, 2025, pursuant to the County of San Diego Charter section 401.4 and County of San Diego Board of Supervisors Policy A-39, "Process to Fill Vacancies on the Board of Supervisors," the Board of Supervisors determined that the method to conduct the special election and general special election, if necessary, will be the Vote Center model.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF
SUPERVISORS OF THE COUNTY OF SAN DIEGO:**

1. The Board of Supervisors of the County of San Diego calls a special election to be held on Tuesday, April 8, 2025, for the purpose of filling the First Supervisorial District seat.
2. Should no candidate receive a majority vote in the special election held on Tuesday, April 8, 2025, a special general election will take place on Tuesday, July 1, 2025.
3. The special election(s) called by this resolution to be held on Tuesday, April 8, 2025, and Tuesday, July 1, 2025, if necessary, shall be conducted utilizing the Vote Center model pursuant to California Elections Code section 4005;

IT IS FURTHER RESOLVED that the Clerk of the Board shall forthwith cause a certified copy of this resolution to be forwarded to and filed with the Registrar of Voters no later than Wednesday, January 15, 2025.
