




Overall Sentiment

Legal Aid Society of San Diego administers the Tenant Legal Services (TLS), providing free legal help, case management, and targeted rental assistance to prevent homelessness. In 2024, 91% of households we served avoided homelessness at case close, and 81% remained in their homes. Prevention is fiscally smart: a chronically homeless person can cost government ~\$50,000 per year, while TLS averaged ~\$1,300 per household who received legal services, case management, or rental assistance. This year, the County cut TLS by 40%. Because the City of San Diego kept level funding for its equivalent program, the greatest impact will fall on residents in D1, D2, and D5, who will have less access to free housing legal services and greater risk of homelessness. I respectfully ask you to restore the 40% cut and commit to stable, countywide TLS funding. It's humane, cost_effective, and essential to keeping families housed. Thank you.
