**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO ACTING AS THE GOVERNING BODY OF COUNTY SERVICE AREAS NO. 26 – RANCHO SAN DIEGO LOCAL PARK DISTRICT, COUNTY SERVICE AREA NO. 128 – SAN MIGUEL LOCAL PARK DISTRICT, COUNTY SERVICE AREA NO. 83, ZONE A – SAN DIEGUITO LOCAL PARK DISTRICT 4S RANCH ADOPTING CHARGES AND CONFIRMING REPORTS RE: LEVIES TO BE COLLECTED ON THE TAX ROLL FOR FISCAL YEAR 2024-25**

WHEREAS, County Service Areas (CSA) were formed under Government Code Section 25210, et seq. or the predecessor to these sections; and

WHEREAS, recodification of the Government Code in 2009 moved the authority to collect CSA assessments and special taxes on the tax roll from former Sections 25215.66a and 25210.77a to Sections 25125.2 and 25215.5 of the Government Code; and

WHEREAS, Government Code Sections 25125.2 and 25215.5(b) authorize the collection of charges on the tax roll in a manner consistent with former Sections 25215.66a and 25210.77a; and

WHEREAS, Government Code Section 25210.3(d) provides that “any... ordinance, resolution, regulation, rule, or any other action of the board taken pursuant to the former Chapter 2.2 before January 1, 2009, shall not be voided solely because of the enactment of this chapter or any error, omission, informality, misnomer, or inconsistency with this chapter;” and

WHEREAS, pursuant to Sections 25210.3(d) and 25210.66a of the Government Code and applicable County ordinances, the Board has determined that a charge for providing local park services by County Service Area No. 26 - Rancho San Diego Local Park District, County Service Area No. 128 - San Miguel Local Park District, County Service Area No. 83 Zone A - San Dieguito Local Park District for Fiscal Year 2024-25 shall appear as a separate item on the tax bill and shall be collected at the same time and in the same manner as ordinary County ad valorem property taxes are collected; and

WHEREAS, the Director, Department of Parks and Recreation, has prepared a written report describing each parcel of real property receiving said services and the amount of the charges for each parcel for Fiscal Year 2024-25, computed in conformity with procedures set forth in, and the charges prescribed by, the applicable ordinances and resolutions of the County Service Areas; and

WHEREAS, such reports were prepared and are on file in the Office of Private Road and Landscape Maintenance and Notice of Hearing thereon given as required by law; and

WHEREAS, pursuant to such notice, on July 17, 2024, a hearing was held on said reports; and

WHEREAS, the Board of Supervisors has heard and considered all objections and protests to said reports and to the charges set forth therein.

NOW THEREFORE IT IS RESOLVED, DETERMINED AND ORDERED as follows:

1. All objections and protests to said reports have been heard and considered and are overruled.
2. Each and every charge set forth in said reports is adopted.
3. Said reports are hereby confirmed.
4. Copies of said reports as confirmed by the Board shall be immediately transmitted to the Auditor and Controller in order that the charges may be collected on the tax roll as provided in Government Code Sections 25210.3(d) and 25210.66a and applicable County ordinances.
