The undersigned, an Assistant Secretary of the California Enterprise Development Authority, a public entity of the State of California, created pursuant to Chapter 5 of Division 7 of Title 1 (commencing with Section 6500) of the Government Code of the State of California (the “Authority”), hereby certifies as follows:

1. A Notice of Public Hearing containing the language attached as **Exhibit A** (the “Notice”) with respect to the plan of finance, the issuance of the bonds, notes or obligations (the “Revenue Obligations”) and the project described therein (the “Project”), was published on the Authority’s primary website address of <https://ceda.caled.org/> on May 14, 2026.

The Notice was published in an area of the Authority’s website which is used to inform members of the general public about public hearings to be held by member jurisdictions affecting them and which is clearly identified and accessible to members of the general public seeking information concerning the plan of finance, the issuance of the Revenue Obligations and the Project.


