#### Overall Sentiment



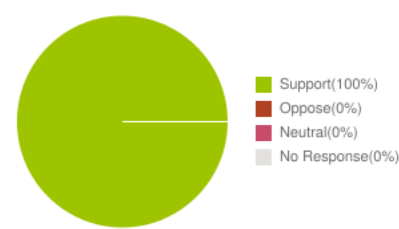

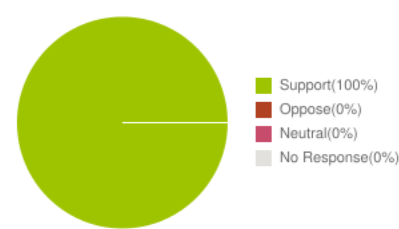
