<u>Item or Service and Term Period</u>: Procurement of livescan devices through the continued service model plan with Idemia Identity and Security USA LLC for a one year term with two one-year option periods, and an additional sixmonth extension, if needed.

Benefits to the County of San Diego: The Sheriff's Office serves as San Diego County's Cal-ID/RAN administrator. Livescans are critical components of the Cal-ID/RAN program as they are the biometric acquisition and identification devices that capture fingerprints and palm prints. The specific devices that are installed are current technology. When the current contract ends, it is not necessary to replace or upgrade the devices. Extending the contract for the continued service model plan allows the County to continue providing the vital tool to law enforcement agencies in San Diego County without increasing the cost.
