ORDINANCE AMENDING SECTIONS 72.161.36., 72.169.27., 72.171.46.3. AND
72.172.33. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON
COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.161.36. of the San Diego County Code is amended:

SEC. 72.161.36. ESCONDIDO. The prima facie speed limit on Felicita Road from the north line of Via Rancho Parkway to the southerly limits of the City of Escondido (north of Miller Avenue) is hereby decreased to and established at 45 miles per hour.

Section 72.169.27. of the San Diego County Code is amended:

SEC. 72.169.27. EL CAJON. The prima facie speed limit on Bradley Avenue from the easterly line of Graves Avenue to the westerly limits of the City of El Cajon (west of Mollision Avenue) and from the easterly limits of the City of El Cajon (east of Mollision Avenue) to the westerly line of First Street is hereby decreased to and established at 35 miles per hour.

Section 72.171.46.3. of the San Diego County Code is amended:

SEC. 72.161.46.3. VISTA. The prima facie speed limit on Buena Vista Drive from the Vista city limit (S/o Keys Place) to Mar Vista Drive is hereby decreased to and established at 25 miles per hour.

Section 72.172.33. of the San Diego County Code is amended:

SEC. 72.172.33. EL CAJON. The prima facie speed limit on First Street between the northerly limits of the City of El Cajon (south of Sumner Avenue) and Pepper Drive is hereby decreased to and established at 30 miles per hour.
