# **Automated License Plate** Reader (ALPR) Cameras

//////

ALPRs are high-speed, computer-

controlled camera systems

• Contain optical character recognition technology to "read" license plates

• ALPRs communicate with law


enforcement databases to aid investigations

> The ALPR technology captures images of license plates and allows law enforcement agencies to identify and compare plates against those of cars driven by people suspected of being involved in illegal activities.

ALPRs will be placed in unincorporated San Diego County.

# **How ALPR Cameras Operate**

Hot listed or Missing/Wanted vehicle is placed into CLETS or Flock Databases



Sheriff's Communication Center and/or field deputies are alerted electronically of a match

Field units react to respond appropriately based on investigation type

# **Benefits of ALPR Cameras**



### Efficiency

Force multiplier for law enforcement agencies and ability to produce case closure rates



#### **Timeliness**

Time is of the essence when it comes to life saving capabilities and public safety



#### Detection

Detect crime suspects, missing persons and vehicles, providing deputies with real time alerts



#### **Enhanced Coordination**

**Enhance department effectiveness** and efficiency for public safety by agency coordination



Investigative Tool
Increase investigative abilities of detectives handling missing and abducted persons, arsonists, violent felonies and series-related crimes

# **Privacy Safeguards**



#### **Training**

Deputies and Analysts are required to complete and successfully pass ALPR specific training and California Law Enforcement Telecommunications System (CLETS) tests before access is granted. CLETS testing is required each year. Advanced investigator trainings will be available in the near future.



#### Access to Information

Deputies and analysts are only allowed access to ALPR information for life-saving and criminal investigation efforts. Sheriff's Flock ALPR data is not commercially shared. Data sharing with other California law enforcement agencies is limited by the Sheriff. ALPR data may not be used for reproductive rights investigations.



#### **Audits**

ALPR data audits are conducted by the Sheriff's ALPR coordinator for compliance to law and Sheriff's Office policy. Violations are referred for administrative investigation.



#### Retention

ALPR data is only kept for 30 days. If the data is needed for a criminal investigation, it may be retained for the duration of the case until adjudication is complete.




#### **Community Awareness**



# **Success Stories**

### >>> Homicide - Lemon Grove

Identified an intentional hit and run homicide.

The suspect was arrested three days after incident.

# >>> Suspects' Vehicles Located

Mobil Gas station, Dick's Sporting Goods, UPS store, Target, and REI impacted by recent thefts but suspects' vehicle was identified and arrests were made.

### >>> Child Abduction - Multi Jurisdiction

Fugitive Task Force members were successful in recovering a child taken during a parental abduction case.

### >>> Commercial Burglary - Multi Jurisdiction

Numerous storage facilities from Solana Beach to the San Diego had been burglarized by a group of suspects. ALPR cameras identified suspect vehicles and led to multiple arrests.

# Recommendation

Pursuant to California Senate Bill 34, receive the Sheriff's Office's presentation on its intent to procure and use Automated License Plate Recognition (ALPR) cameras in the unincorporated areas of San Diego County and allow for public comment.
