RESOLUTION AMENDING TRAFFIC RESOLUTION NO. 2663 RELATING TO THE TEMPORARY CLOSING TO THROUGH TRAFFIC ON A COUNTY HIGHWAY AS A RESULT OF SERIOUS AND CONTINUAL CRIMINAL ACTIVITY IN THE COUNTY OF SAN DIEGO

WHEREAS, this Board by Traffic Resolution No. 2663, passed and adopted July 18, 2001, established certain Temporary Road Closures in the County of San Diego; and WHEREAS, it is necessary and expedient that said resolution be now amended to extend a certain Temporary Road Closure heretofore included;

WHEREAS, the Board of Supervisors finds in accordance with Vehicle Code section 21101.4(b) that:

- The San Diego County Sheriff's Department and California Highway Patrol
 recommended the continuation of the closure and that the closure will assist in
 preventing the occurrence or reoccurrence of the serious and continued
 criminal activity the closure was instituted to prevent;
- 2. The highway to be closed is not designated as a through highway or arterial street by the County;
- 3. Vehicular traffic on the highway contributed to the criminal activity sought to be stopped by the closure; and
- 4. The immediately preceding closure has not substantially adversely affected traffic flow, safety on the adjacent streets or in the surrounding neighborhoods, the operation of emergency vehicles, the performance of municipal or public utility services, or the delivery of freight by commercial vehicles in the area of

the highway that was temporarily closed.

NOW THEREFORE BE IT RESOLVED that said Traffic Resolution No. 2663 be and the same is hereby amended as follows:

Items No. 2, 4, & 5 of the list of Temporary Road Closures established by said resolution is hereby extended for an additional 18 months to read as follows:
